a. **November 8, 2022, General Election**

1. **Outreach Events**- On October 21st the San Benito County Elections Department had a workshop with Hope Services. We went over what was on the ballot, what ballot designations are, and what each office position does. The workshop was very informative to the participates they felt more prepared to vote.
 2. **Voter Turnout**- San Benito County's current voter turnout is less 5%
 3. **Election Officer Training**- The training was extended this election from 4 hours to 7 hours. The elections department determined that it was necessary to extend the training to be able to go in depth about each topic. Karie Lew from Disability Rights California presented on how to assist voters with disabilities and how to properly ask voters if they need assistance. Karie Lew asked the San Benito County Elections Department to send the surveys and the number of attendees at the training.
