Brief Overview of HCPs and NCCPs

Federal Endangered Species Act (ESA)

Purpose and policies:

- Purpose: Conserve ecosystems and species that depend on those ecosystems
- Policies: Federal agencies should use existing authorities to conserve species and cooperate with state programs



Federal ESA Section 9: Prohibited Acts

- Prohibition: All persons are prohibited from importing, exporting, *taking*, transporting, or selling fish and wildlife species listed as endangered under federal ESA
- Take: Action of or attempt to hunt, *harm*, harass, pursue, shoot, wound, capture, kill, trap, or collect a species
- Harm: Any act which actually kills or injures species, including *significant habitat modification* or degradation where it actually kills or injures wildlife by significantly impairing essential behavior patterns, including breeding, feeding, or sheltering



An Exception to Federal ESA Section 9

- Section 10:
 - Primary mechanism to securing an exception is development of a *habitat conservation plan (HCP)*
 - Product is an *incidental take permit (ITP)* that binds the applicant to the terms and conditions of the HCP




California Endangered Species Act

- Endangered and Threatened Species: Prohibition against commerce and taking of state-listed endangered and threatened species
- Take: Hunt, pursue, catch, capture, or kill or attempt to hunt, pursue, catch, capture, or kill:
 - Unlike Federal ESA definition it does not include harm, injury or harassment



California State Take Authorization

- Incidental Take Permits Section 2081(b):
 - Take incidental to otherwise lawful activities
 - Individual projects
- Landscape-scale:
 - Natural Community Conservation Planning Act (NCCP Act)



Natural Community Conservation Planning Act

- Natural Community Conservation Plan:
 - Similar in structure to an HCP, but with additional requirements
 - Typically regional (e.g., county-wide)
 - Can be issued for both listed and non-listed species
 - Provides for mitigation and additive conservation
 - Requires "measurements to determine if mitigation and conservation measures are being implemented *roughly proportional* in time and extent to the impact on habitat or covered species"
 - Consequence of not maintaining rough proportionality is permit revocation



Types of HCPs

Project HCPs:

- Single applicant
- Large or small scale, single or multiple species
- Short or long duration

• Regional HCPs:

- Multiple applicants, multiple species
- Large scale
- Long duration
- Programmatic
- Low-Effect HCPs




Types of HCPs (Cont.)

Regional HCPs:

- When local jurisdictions receive take authorization, they can extend take coverage to:
 - Departments of their jurisdiction
 - Private applicants under their control
- Increases local control
- Creates large-scale "mitigation program"



Regional HCP/NCCPs: How They Work



HCP and NCCP Assurances: No Surprises Rule

- Provides assurance to permit holders in the case of changed or unforeseen circumstances
- Changed Circumstances:


- Changes affecting species or geographic area covered in a plan *that can be reasonably anticipated* by plan developers and USFWS or NMFS (e.g., new species listings, fire, climate change, or other foreseeable disturbance)
- Changed Circumstances Provided for in the Plan:
 - Permittee must implement remedial measures for changed circumstances identified in the plan

HCP and NCCP Assurances: No Surprises Rule (Cont.)

Unforeseen Circumstances:

- Changes affecting species or geographic area covered in a plan that *could not have been reasonably anticipated* by plan developers and USFWS and that result in substantial adverse change in the status of a covered species
- Permittee not required to implement remedial measures for unforeseen circumstances
- USFWS may require additional conservation measures *if measures do not involve commitment* of additional land, water, or financial compensation, or additional restriction on land use, water, or other natural resources

California NCCPs



NCCP: Natural Community Conservation Plan (California Fish and Game Code §2800) (https://www.wildlife.ca.gov/Conservation/Planning/NCCP) HCP: Habitat Conservation Plan (Federal Endangered Species Act Section 10) (http://www.tws.gov/endangered/what-we-do/hcp-overvlew.html)



Conservation plans may be in various stages of review, and subject to change. In some cases, boundaries have not been submitted by participants, and are estimated locations.
