Our History in San Benito County

- 2005 Waste Connections begins operation of John Smith Road Landfill.
- 2010 December 21st after **unanimous approval** by Board of Supervisors, Waste Connections enters into a new operating agreement with exclusive rights to operate the landfill and plan for a future new site/expansion. This marks the beginning of our public/private partnership that continues today.
- 2013 JSRL ramped up out of County waste flow to 400 tons/day at which point the new "life of site" operating agreement is triggered.
- 2019 After another unanimous approval by Board of Supervisors, a 2nd agreement with terms benefiting the County, is finalized naming the Lima property as the new expanded area of the existing landfill.
- 2020 Waste Connections purchases the Lima property and began the Environmental Impact Review process.



Landfill Capacity Summary

Existing Landfill

- 90.36 acres permitted area
- 58 acres permitted disposal area
- 9,797,000 cubic yards of permitted capacity


Proposed Expansion

- 388 acres total expansion area
- 195 acres additional disposal area
- 46,421,000 cubic yards of additional airspace
- Gradual increase from 1,000 tpd to 2,300 tpd

Alternatives to Landfill Expansion

Transfer Station

- Where would this be located?
- Construction costs
- Ongoing operations and maintenance costs
- Transfer trucks traveling through County to an Out-of-County Landfill
- Replacement cost
- Pay host disposal fee to Monterey County, City of San Jose, or Merced County (forever)
- Significant garbage rate increase for County residents and businesses



Expansion Benefits – to County Residents

- Rate stabilization for County residents and businesses
- Construction of new **Re-Use shop**/mercantile at landfill entrance
 - Allows customers to drop off/purchase household goods with proceeds <u>donated to</u> <u>local charities</u>.
- Local resource to assist with **emergency response** to natural disasters
- Continued **community partnerships** & support through annual Christmas bike giveaways and other charitable giving opportunities

Expansion Benefits – to the County

- Waste Connections pays County up to **27% of gross** revenue, based on tons received.
 - \$69.4 million^{*} over the first 15 years of the expansion
 - \$410.4 million^{*} over the entire life of the landfill

Expansion Benefits – to the County

- Continued operation development of **state-of-the-art landfill**
- San Benito County Board of Supervisors maintain complete control over the future of solid waste in the County
- Clean Closure* of Hollister's Class 1 landfill
- **Tax generation** from local point-of-sale purchases for landfill equipment, liners, and other ongoing operational needs

*Currently overseen by the Department of Toxic Substances Control (DTSC)







Why Accept Out of County Waste?

- Small, low-tonnage landfills do not survive • Cost per ton is too high, reducing customers, and leading to closure
- Federal Subtitle-D is forcing closure of low-volume, rural landfills

What to Expect

- Tonnage will increase gradually (estimated with round numbers per EIR document)
 - Year 1 900 tons per day
 - Year 5 1,200 tons per day
 - Year 10 1,700 tons per day
 - Year 15 2,100 tons per day
- Recommended path to landfill for out-of-County waste:
 - Hwy 25 > Best Road > John Smith Road > Landfill
 - Minimize travel on County roads which benefits the County
 - Results in no out-of-county landfill traffic on Fairview Road
 - Maximizing travel on State Route 25





Road Impact Analysis Best Road Alternative

- Total road impact dollars paid by Waste Connections at time of entitlement = \$4,845,000
- County analysis shows landfill share of cost at 2,300 tpd

 Initial road improvement cost
 Annual fee (year 1- year 23)
 Annual repair fee (year 1 year 23)
 Year 24)
 Year 25)
 Year 26)
- Summary Our initial payment for road impact more than covers costs for Best Road for initial 23 years.





Road Impact Analysis *Out-of-County Traffic - Best Road Alternative*

- Projected landfill revenue share payments to the County:
 - o Years 1 through 23 = \$84,872,997
 - Projected year 24 = **\$11,837,011**
- Annual Best Road impact requirement for year 24 = \$143,471
- We request annual road impact requirement for year 24, and beyond, be paid from landfill revenue share made to the County.







Summary

- Environmental Protection with a Proven Partner
 - $\,\circ\,$ Expansion will provide multiple tiers of continued environmental protection
- Local Control
 - $\,\circ\,$ County will remain in control of solid waste management for 65+ years
- Financial Benefits for County Residents
 - $\circ\,$ Rate stabilization for San Benito County residents and businesses
 - $\,\circ\,$ Expansion provides significant revenue to San Benito County
