Those who have made such contributions are required to disclose that fact for the official record of the proceedings. Disclosures must include the amount of the contribution and the recipient Commissioner and may be made either in writing to the Executive Officer of the Commission prior to the hearing or by an oral declaration at the time of the hearing.

The foregoing requirements are set forth in the Political Reform Act of 1974, specifically in Government Code section 84308.

RECOMMENDATION

Review the applications submitted for public member positions on San Benito LAFCO, and vote to appoint the Regular Public Member and the Alternate Public Member to the remaining terms expiring in May 2020.

DISCUSSION

The Alternate Pubic Member, Commissioner Mark Tognazzini, has submitted his resignation from the Commission due his recent appoint to the County Planning Commission, and therefore, there is a vacancy in the alternate public member position on the Commission. In addition, Vice Chair Richard Bettencourt's four year term on the Commission expired in March 2016, and therefore the Commission needs to either reappoint Commissioner Bettencourt, or make a selection from other qualified applicants who submitted application forms by the Commission meeting on March 23, 2017.

According to Government Code section 56325, the public member vacancy must be posted on a notice outside the hearing chambers, and sent to the clerk or secretary of the legislative body of each local agency within the county at least 21 days prior to the meeting date to make a selection. This noticing and posting has been accomplished as of March 1, 2017. The candidate selected must receive one affirmative vote from both a city and a county member of the Commission. The vacant regular and alternate City Commissioner seats on the Commission should be filled by the March 23rd meeting, and therefore it is timely to appoint the public member positions.

As of the preparation of this memo on March 16, 2017, only one application from Commissioner Bettencourt has been received (enclosed). Any other applications

Dear Members of the Commission:

RECOMMENDATION

It is recommended the Commission adopt the resolution to change the day of the regular Commission meeting from the fourth Thursday of the month to the second Thursday to avoid conflict with other conflicting meetings, and give direction to staff to produce a new meeting calendar.

DISCUSSION

At the October 20, 2016, Commission meeting, the Commission discussed their general support for changing the regular Commission meeting after input was received that the Commission meetings pose a hardship on City of Hollister staff and applicants as the City's Planning Commission meeting is on the same night, the fourth Thursday of each month, starting at 7:00 pm. The current one-hour separation between LAFCO and City Planning Commission meeings makes it difficult or impossible for City staff, and project applicants, to attend the LAFCO meeting on important City applications.

At the request of Counsel, it was recommended that Staff come back with a resolution amending the Commission Rules and Procedures as a formal means for changing the regular meeting time. While the second Thursday of each month has been recommended, the Commission may wish to select another day or week of the month if this suggested change is no longer satisfactory.

WHEREAS, pursuant to the Cortese/Knox/Hertzberg Local Government Reorganization Act (Government Code Section 56300 et seq.) the Commission is required to establish written policies and procedures and exercise its powers pursuant to the Government Code and those adopted local policies and procedures; and

WHEREAS, the Commission has adopted local rules and procedures which set forth the date and time of regular Commission meetings in Section 5.C. of the "LAFCO Rules and Procedures" adopted by the San Benito LAFCO on Junary 28, 2016, as part of the "Commissioner Handbook;" and

WHEREAS, the Rules and Procedures specify the regular meeting shall be held on the fourth Thursday of each month except June, November and December; and

WHEREAS, the Commission has heard objections to this meeting time because it conflicts with the long established monthly meeting time of the Hollister City Planning Commission; and

WHEREAS, if the week of the month Commission meetings are held is moved to the second week, there are no longer conflicts to holding meetings in the months of June, November and December; and

WHEREAS, the Commission has the independent discretion to determine the date and time of their regular meetings, in addition to having the power to set special meetings as needed.

NOW THEREFORE, IT IS RESOLVED AND ORDERED that the Commission hereby changes the meeting time referenced in Section 5.C. of the "LAFCO Rules and Procedures" to read:

"Regular meetings of the Commission shall be held on the second Thurday of each month."

Fiscal Year 2017-18 Budget Process and Considerations (Agenda Item 6)

Dear Members of the Commission:

RECOMMENDATION

No action is required by the Commission, only a discussion and general direction of ideas for the upcoming budget process.

DISCUSSION

It is the time of year where we need to begin the budget process for the 2017-18 Fiscal Year. The LAFCO law under Government Code Section 56381(a) governs the preparation of the LAFCO budget with the following provisions:

The commission shall adopt annually, following noticed public hearings, a proposed budget by May 1 and final budget by June 15.

At a minimum, the proposed and final budget shall be equal to the budget adopted for the previous fiscal year unless the commission finds that reduced staffing or program costs will nevertheless allow the commission to fulfill the purposes and programs of this chapter.

The commission shall transmit its proposed and final budgets to the board of supervisors, to each city, and to each independent special district.

Accordingly, it is anticipated that the proposed budget will be presented at the April Commission meeting (either April 15 or 27) and the final budget presented at the May meeting.

This item was placed on the March Commission Agenda to give the Commission an opportunity to identify any special work program items that should be included in the budget in the coming year. These would typically include initiation of Municipal

Service Review (MSR) updates or Sphere of Influence updates which require periodic review and confirmation by the Commission. If there are policy issues of concern, including a review of local LAFCO policies, this can also be included. A determination would also need to be made where work may need to be performed by consultants if the workload is beyond the capacity of the Executive Officer.

Following on this topic, the Executive Officer has had to perform more clerical oriented tasks than anticipated due to shortage of support staff by the County. Therefore, I would like to discuss the consideration of having my wife perform some support role similar to the arrangement with the former Executive Officer, Bob Braitman.

Otherwise, any other projects the Commission desires to identify may be discussed during this agenda item.

Rustic Street Annexation to City of Hollister – LAFCO 514 Results of Protect Hearing (Agenda Item 10)

Dear Members of the Commission:

RECOMMENDATION

It is recommended the Commission receive and file this report.

DISCUSSION

The Rustic Annexation to the City of Hollister was initiated by the City on January 25, 2016, and was approved by the Commission on October 20, 2016.

Because the Commission did not receive written consent of all affected landowners it was necessary to notice and conduct a protest hearing following LAFCO's approval. The Commission has delegated to its staff the responsibility to conduct such protest hearings.

The staff conducted the required protest hearing on Thursday, December 8, 2016 in the Board of Supervisors chambers. Written protests calculated after the hearing was closed were not sufficient to require that an election be conducted to confirm the annexation.

The annexation was recorded and the property is within the City as of January 13, 2017. This action also allowed the adjacent Maple Park Annexation (LAFCO File 513) to be recorded on the same date as no County island was created from the annexation.
