BOUNDARY CHANGE PROPOSALS

5. LAFCO No. 502A – El Cerro Annexation to the City of Hollister

Commissioner Velasquez recused himself from this hearing based on a business relationship with one of the past speakers on this matter and exited the hearing room for the remainder of this item. Vice Chair Botelho assumed the Chair.

The Executive Officer presented the staff report. Staff noted the annexation is inhabited, having 29 registered voters as verified by County Elections.

Testimony was provided by affected landowners Cruz Arballo, Christina Salvin and Christian Trejo. Ms. Salvin read a statement from Tajni Diller, president of the El Cerro Homeowners Association. Also speaking were William Avera representing the City of Hollister and Matt Kelley representing property owners in the Hillcrest Annexation area.

After due consideration, upon motion by Barrios, second by Bettencourt, the Commission found the proposal to be Categorically Exempt and approved the proposal conditioned

upon the property being liable for existing or authorized taxes, charges, fees or assessments comparable to properties within the City.

The staff was directed to properly notice and conduct a protest hearing for landowners and registered voters within the annexation area and report the results to the Commission. The staff was directed not to complete the proceeding until the map and legal description are found to be acceptable by the County Surveyor.

6. LAFCO No. 502B – Hillcrest Annexation to the City of Hollister

Finding the territory is uninhabited, all landowners have given written consent and the annexing agency consents to the waiver of conducting authority proceedings, the Commission directed staff to complete the proceeding when the County Surveyor finds the map and legal description are acceptable.
