Update on New Staff Department Organization relative to PRC and County Parks and Recreation Program.

Resource Management Agency representative Adam Goldstone reported that the recruitment for a Capital Projects Manager was unsuccessful.

V. COMMISSIONER REPORTS

Commissioners' Report.

Commissioner Nelda Escamilla reported that she had an idea to invite the cities' Parks and Recreation Commissioners on a tour of the parks.

Commissioner Marie Peterson reported that she met with Supervisor Mark Medina and he wanted to know if there was a status update on the Santana Park. Adam Goldstone said that he does not know what the status is, but the Planning Department would know. Commissioner Hain asked if he could bring an update to the Commission at their next meeting.

Commissioner Maria Spandri reported that she has been working on having the high school carnival take place at Vet's Park and has been successful in getting all the entities that use the park to agree to have it there. She also raised concerns about the Park and Ride area of the park that is full of broken glass and said she is worried about vandalism and fire risks. She also suggested that the Commission revisit the idea of having two youth commissioners on the Commission as has been done in the past. She said it is important to have a different viewpoint on the commission.

Commissioner Tim Powers reported that the Community Center Foundation in Aromas is putting

out a grant for an accessible playground. The work on the soccer field is still ongoing and the dog park portion of the park also has funding. There is also a small contingent of people who are working on painting the bridge in Aromas that separates San Benito, Santa Cruz, and Monterey Counties.

Adam Goldstone reported that there is no update. There has been lots of talk, but no actions taken.

B. PARKS AND RECREATION COMMISSION

Update on proposed restoration of the Tres Pinos Creek at the San Benito County Historical and Recreational Park.

Commissioner Hain asked if there was any update from FEMA regarding the flood.

Adam Goldstone responded that he is not aware of anything and does not know what the status is. He suggested that the Commission check with the engineering team or public works.

C. PARKS AND RECREATION COMMISSION

Update on plans for water treatment at the Historical Park.

Adam Goldstone reported that this has been on the list of things to do but it hasn't been completed yet.

Commissioner Spandri spoke about the importance of water for events at the historical park.

D. PARKS AND RECREATION COMMISSION

Update on Regional Park.

Adam Goldstone reported that the acorn planting at the park has been delayed due to the rain. About 100 acorns have been planted as of now and they are waiting to see how many take.

He also reported that there has been discussion with the high school regarding the parking situation at the park. The high school has built a lot, but the County may need to build their own lot. The high school has some security concerns and there are issues with access and use. He spoke about potential locations for parking.

He reported that REACH San Benito Parks Foundation has volunteered to do work at the park. The County also has a surveyor under contract who will be marking the southern boundary edges when weather permits. There are still problems with people going off-road at the park, though the weeds have helped with this a little.

He also reminded the Commission that the budget for the County is coming up and asked them to

think about what items they want to recommend to the Board of Supervisors for funding. Discussion about the Master Plan and requirements for budget recommendations ensued.

Valerie Egland, a REACH San Benito Parks representative, reported that there has been a lot of interest regarding the moonlight walk. She also spoke about the need to clean up the entrance to the Anza trail, which is the County's responsibility. She also raised a concern about a fish business that washes their trucks out and causes the road to smell.

E. PARKS AND RECREATION COMMISSION

Discussion of dates and place for retreat.

Commissioner Powers reported that March 24, April 7, and May 19 were the dates that got the most votes for having the retreat. He said that March 24 seems a little too soon. Commissioner Peterson stated that May works better for her. Commissioner Spandri said that April is the only date that works for her.

The Commissioners decided to tentatively schedule the retreat for Sunday, April 7 from 8:30 a.m. to 3:00 p.m.
