### **BUSINESS ITEMS – PUBLIC HEARING ITEM**

5. Consider adoption of the Proposed Fiscal year 2018-19 Budget.

Chairman Flores introduced the item.

Commissioner Gillio said that he had a question on page 3 in the revenue section. He said that there are points in there than concerned him so he reached out to the County Budget Officer Stewart Patri to learn more about that. He said it looked like there was one \$40,000 payment from the City of Hollister for this fiscal year. He said what actually happened was that payment was for last fiscal year recorded on January 2019. He said that we haven't received any payments for the fiscal year yet and the County has not submitted any payments. He said what happens according to our fiscal officer is that at the end of every fiscal year we settle up.

there will be payments made in the middle of the year. He said he would keep track of that to make sure the County is paying their portion along with the City of Hollister and San Juan.

Executive Officer Nicholson added that he missunderstood, it showed up as a revenue payment. He said that he does know for LAFCO is independent from the City and County, it has its own budget and LAFCO's payments for support of LAFCO comes from applications from annexations and also from the Cities and Counties paying the balance. The City and Counties only pay what LAFCO actually spends not what is approved in the budget. He said that the auditor will determine at the end of the year what was revenue and what was expenditures. He thanked Commissioner Gillio for clarifying that.

Commissioner Bettencourt had a comment on the budget in regards to the legal counsel services in the amount of \$10,000 and how it wasn't used and if it was moved to another account.

Executive Officer Nicholson provided information that if they do not spend all of the money in any of the categories it just doesn't get spent they do not move it to another account.

Commissioner Bettencourt said another concern was the medical insurance costs for a former Executive Officer settlement for a retired employee. Why are we responsible for that and not the County?

Executive Officer Nicholson said he was not here and that this issue has been raised in past budgets. He said at the time the response has been that the person worked for the County but was assigned to do LAFCO functions, so she left the County under whatever terms and it was an agreement that the County would pay her benefits, so they split the cost for her medical between LAFCO and the County based on her time that she spent between the two duties. He said it is an unusual thing to have on the budget but the person was a County employee.

Commissioner Gillio asked what year this was.

Executive Officer said possibly 2012.

Commissioner Velazquez stated it was before that because when he got on board that person wasn't here and that was 2013. He said it is something that we need to address; you make a really good point. He said it is something that we need to have a larger conversation about, that is a lot of money.

Executive Officer Nicholson said that this is a proposed budget and then we have a final budget on June 12<sup>th</sup>. He said that he could come back and report the final budget of that amount and how it got set and what we can do about it, if anything.

Commissioner Gillio asked if maybe we could get a legal opinion because it sounds like something that the County should be responsible for but would like to know for sure.

Commissioner Bettencourt said another concern on that issue was wouldn't Counsel have to recuse themselves.

The Executive Officer Nicholson and Commissioners said they did not believe they would have to.

Commissioner Flores had a question that it says proposed budget 2018-19, was that correct.

Executive Officer Nicholson replied, no it should be 2019-20, that is a typo. He said the hearing notice is correct for 2019-2020. Thanked Commissioner Flores for catching that.

Commissioner Bettencourt said the County hasn't been charging us for a lot of the services that they help you out with as far as getting a packet together and so forth. I see that this year it is in the budget. .

Executive Officer Nicholson replied that since he has been here for three years he has a better ideas what it costs to do things and has moved money around from different categories. He said that the County doesn't bill everything to LAFCO for what they do.

### **BOUNDARY CHANGE PROPOSALS – PUBLIC HEARING ITEM**

5. LAFCO 529-Nguyen Subdivision Annexation to County Service Area (CSA) No. 24: Involving the annexation of approximately 8.63 acres of property and a portion of the adjacent roadway into the County Service Area No. 24. The property is located on the east side of Rosebud Avenue and approximately 1,000 feed north of Santa Ana road, involving Assessor's Parcel Number 019-180-045, and is proposed for a division into seven residential lots. ### **APPROVED BOUNDARY CHANGE PROPOSALS**

6. LAFCO 526-Chappel Road Annexation to the City of Hollister, status report on protest hearing conducted Marcy 28, 2019.

Chairman Flores introduced the item.

Executive Officer Bill Nicholson provided information, that this was an annexation to the City of Hollister regarding property on the inside curve of Hwy 25 bypass for the City of Hollister. When LAFCO approved the annexation they added 2 parcels and because the landowners hadn't agreed to the annexation we had to hold a protest hearing. We held the protest hearing and no one showed up, so there was not a protest filed and, therefore, the annexation will move forward with the recordation. No further action is required by the Commission on this he said it was just a report back.

Executive Officer Bill Nicholson provided information and provided a PowerPoint Presentation which covered the following in regards to Ag Land and CALAFCO White Paper: State of the Art on Agricultural Preservation; State of California's Farmland (Facts on California Farmland, 1984-2014); Resilient Agriculture; Resilient Commodities; San Benito County Soil Map-North County; Approaches to Agricultural Preservation Policies; Farmland Preservation Tools - #1 Avoid Impacts; #2 Minimize Impacts, #3 Mitigate Impacts; What is the purpose of LAFCO - One of the main priorities is to promote orderly development and in balancing that development with sometimes competing state interest of discouraging Urban Sprawl preserving open space and prime agricultural land and officially extending So the State knows that you have to support governmental services. development and LAFCO is a lot about efficient development such as do you have capacity for sewer, water and adequate mechanism to get police and fire service. LAFCO also looks at the Ag land, open space and tries to protect that. When you sit here you sit here as a LAFCO Commissioner and Ag land and open space is one of the tenants of that.

Mr. Nicholson invited Sara Steiner, Secretary from the San Benito Agricultural Land Trust to finish up the presentation to provide information on their Trust.

Dan Dungy, President, of the San Benito Land Trust, did an introduction on the Land Trust. He introduced some of the members: Sara Steiner, Secretary; Emily Renzel, Paul Hain, Vice-President; Karminder Brown and Lynn Overtree.

He said that they have been around for 25 years and have over 6,000 acres of conservation easement land that they manage and own fee title on about 550 acres of grazing land.

Sara Steiner San Benito Agricultural Land Trust spoke of two San Benito County mitigation funds received recently. Spoke of how Development Mitigation Funds benefit landowners; how development mitigation funds become a community benefit; provided how the San Benito County Farm Bureau supports them; Questions.

Commissioner Bettencourt said that he is all for preserving Ag. Had a question about tax structure on an easement that is bought by a developer and the tax base.

Ms. Steiner provided information.

Commissioner Gillio said that I think the value of the property is reduced because there is no development potential. So the amount of property tax that is collected is also reduced. He said that he is all for the Land Trust and has attended some of them. He said that farming is changing and you can't make the money you use to.

Ms. Steiner said a conservation easement is a big benefit, it gives the landowner funding to expand, invest, pay off loans, etc.

Commissioner Velazquez asked how soon can we meet. He said that this is very important to him and farming is important. He said that he appreciates what they are doing.

Discussion ensued by Commissioners, staff and San Benito County Land Trust.

This was a presentation only.

Chairman Flores thanked everyone who presented.

### 8. Consideration of changing Commission meeting day and start time to 3:00 p.m. on the Third Wednesday of each month.

Chairman Flores introduced the item.

Commissioner Medina said that he is not a big fan in moving the time of the meeting during the day people work. He said that he would like to move to 6:00 p.m. to allow the public to attend.

Commissioner Bettencourt said that he was o.k. with what the rest of the commissioners wanted to do.

Commissioner Gillio said that Commissioner Medina was not here at the last meeting when we discussed this. He said that he understood what he said but was more comfortable in doing it at 3:00 p.m., but would go with the majority if they want to keep it at 5:00 p.m. He said that he would like to examine the day to try and line it up with some of our other current meetings.

Commissioner Velazquez said that we have had this conversation many times and he totally understands what you are saying. He said that we have had evening meetings and no one shows up, moved them earlier no one showed up. He said that it really comes down to the item on the meeting whether people are going to come out. He said that it is tough on all of us. He said we had a conversation at the last meeting in regards to trying to line up some of the other meetings at the same time. He said we talked about 3:00 p.m. before the COG meeting. He said he would side for the 3:00 p.m. possibly the 3<sup>rd</sup> Thursday to line up with COG.

Discussion endued by the Commissioners.

Executive Officer Bill Nicholson said that he needed to make one point clear, the next agenda is going to have to have our final budget and under the State Law LAFCO has to adopt their budget by June 15<sup>th</sup> and we need to publish 21 days before. He said that we are kind of stuck for the next meeting on picking the same day which would be the second Thursday, June 13th. He said an option would be to come back the next meeting with a calendar of the other meetings, both City and County, and I can work with Janet on the options. He said that if the commission would like to set a different time for the June 13<sup>th</sup> meeting they could do that, but the meetings have been at 5:00 p.m.

9. Update on CALAFCO tracked legislation and consider letter of opposition to AB 600 (Chu) which requires all cities, counties and certain special districts to develop accessibility plans if they have disadvantaged unincorporated communities identified in the General Plan Land Use Element, and for LAFCO to hold public hearings after adoption of the accessibility plans and if necessary, initiate changes or organization or service extensions to provide services to the identified communities. Also consider letter of support for AB 1822 (Commission on Local Government) involving the annual omnibus bill sponsored by CALAFCO with technical, non-substantive changes to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000.

Executive Officer Nicholson said for the two Assembly Bills: AB 600 (Chu) letter of opposition, and AB 1822 (Commission on Local Government) letter of support. AB 600 was recently amended due to widespread opposition, and we need to modify the arguments against the Bill as modified.

Mr. Nicholson provided additional information. He said the sphere of influence is a boundary set by LAFCO, not set by a City or County or special district, LAFCO has to approve the sphere. ### 11. Executive Officer oral status report on pending proposals.

Executive Officer Nicholson announced that there is another subdivision to be annexed into CSA #24 and we will have that application coming within the next couple of meetings.

He said that we also found seven years ago LAFCO approved the annexation at the west side of Rosebud Avenue into CSA #24 and in order to collect taxes on it you need to record it and LAFCO never recorded it, so it is approved by LAFCO and LAFCO has a year deadline to complete an action that was approved and it had been over six years. So we will need to redo the application for that one and will be coming at a later date.

He said that another application that he received is from the Aromas Water District for annexation of a donut hole in the middle of the Rancho Larios Subdivision which will be coming in the next couple of meetings.

### Final LAFCo Budget for FY 2019-20 (Agenda Item 6)

Dear Members of the Commission:

#### RECOMMENDATION

It is recommended the Commission:

- 1. Review the Final Budget for Fiscal Year 2019-20, accept all public testimony and approve the Final Budget with any desired modifications.
- 2. Direct staff to distribute the Adopted Budget to cities, special districts and the County as required by Government Code Section 56381.
- 3. Authorize the County Auditor-Controller to adjust the amounts collected from local agencies for LAFCo operations based on the actual year-end fund balance.
- 4. Direct staff to advise the Commission of any changed budgetary conditions that could adversely affect the Commission's ability to fulfill its responsibilities in the coming year.

### DISCUSSION

### Introduction

Staff is recommending adoption of the Final Budget for Fiscal Year 2019-20 to meet the statutory deadline for adoption by June 15<sup>th</sup>. No comments were received from the County, Cities or special districts as a result of the required mailing of the Preliminary Budget as adopted by the Commission on April 25, 2019. Notice this public hearing was published as required by LAFCo statute.

### **Appropriations**

The Proposed Budget requested \$141,497 in appropriations, which reflected a \$6,588 increase from the FY 2018-19 budget. There are no recommended changes in appropriations for the Final Budget. However, there was a slight error in the proposed Budget spreadsheet titled "Explanation of Accounts" which incorrectly identified the increase in budget appropriations to be \$299 higher (\$6,887 instead of the actual increase of \$6,588). The increase is primarily the result of a \$9,427 addition in Board Clerk support costs for agendas, minutes, and support with legal notices and mailings; and an increase in the amount of \$7,000 for the Executive Officer to support the County in preparation of a Municipal Service Review update for County Service Areas (CSAs) through a professional contract with a consultant to be retained by the County.

These increases were partially offset by reductions in several accounts identified in the attached "Explanation of Accounts" with a \$7,204 reduction in Geographic Information System (GIS) mapping and data gathering costs being the primary savings.

The Commission should be reminded that appropriations that are not expended during one fiscal year become part of the Available Fund Balance and reduce the amount to be collected from the County and Cities for LAFCo operations at year-end.

### Revenues

Contributions from the County and cities represent the great majority of LAFCo revenue. In the current fiscal year, revenue from application fees for processing boundary changes and modifying spheres of influence is anticipated to generate approximately \$10,000 in income, 50% to 75% lower than in previous years. The balance of full budget costs are provided through billing by the Auditor's Office to the County (50%) and the City's of Hollister and San Juan Bautista sharing the other 50%. For perspective, after three-quarters of the fiscal year, LAFCO costs were only \$59,460 of the budgeted annual total of \$134,610. The Auditor will only bill the cities and county based on actual expenditures, not on the adopted budget amount. The cities split their share of costs based on the percentage of total revenues received by each city. Based on the State Controller's website, in 2017 Hollister received 93.725% of total city revenue and San Juan Bautista received only 6.275%. For the previous fiscal year, the Hollister contribution amounted to \$40,792, so San Juan Bautista's share would have only been around \$2,700, and the County's 50% share was around \$43,500.

#### Conclusion/Recommendation

In consideration of this information, it is recommended the Final Budget be approved and distributed to local agencies as required by Government Code Section 56381; the

Auditor-Controller be requested to adjust the actual amounts billed to the County and Cities for LAFCO operations to reflect the actual the year-end fund balance; and that staff be directed to apprise the Commission of any changed conditions during the fiscal year which could adversely affect the Commissions ability to fulfill its responsibilities.

The Commission received a PowerPoint presentation from LAFCo staff and representatives of the San Benito Agricultural Land Trust at the May 9, 2019 regular Commission meeting. The presentation included information from the document entitled: "State of the Art on Agricultural Preservation" – a White Paper prepared jointly by the California Association of Local Agency Formation Commissions (CALAFCO) and the American Farmland Trust. Following the presentation, Commissioners asked questions and engaged in a dialogue with the representatives of the San Benito Agricultural Land Trust (SBALT), but did not take any action.

At the request of Commissioner Bettencourt, with confirmation from LAFCo Chair Flores, this topic has been placed on the June 13<sup>th</sup> Agenda for additional discussion with a focus on the role LAFCo can play in protecting prime and important farmland in San Benito County. The White Paper identified a hierarchy of three measures LAFCos can take to protect farmland:

- 1) AVOID the conversion by encouraging infill development on vacant and underutilized land within existing city and unincorporated community boundaries;
- 2) MINIMIZE the conversion of farmland by developing at higher densities so more growth can be accommodated on less farmland, and directing growth to lower quality soils rather than to prime farmland; and
- 3) MITIGATE for the loss of productive farmland when conversion cannot be avoided, such as through obtaining conservation easements to permantly protect farmland within the County on high quality soils where irrigation water is available.

While the General Plans of the Cit of Holliser and San Juan Bautista, as well as the County all discourage conversions of productive farmland, all the plans include land designated for urban development that is currently in productive agricultural use. Historically there was nothing done to compensate for the loss of this important resource as the communities urbanized. However, more recently both the City of Hollister and San Benito County have identified agricultural mitigation as a requirement in the CEQA (California Environmental Quality Act) documents for development projects.

Three recent projects were "The Promontory at Ridgemark" housing project on Southside Road in the County, and the "Chappell Road" and "Villalpando" Annexations into the City of Hollister next to the State Highway 25 Hollister Bypass. These projects all required the applicant to obtain conservation easements on similar quality farmland within the County at a 1:1 ratio of farmland converted to land placed under an easement. The San Benito Agricultural Land Trust is in the process of developing programs and procedures to be able to receive and manage easements required as mitigation for development projects in their role as a non-profit trust.

As the City of Holliser initiates their General Plan update, with consideration of adjusting their sphere of influence to more accurately reflect desired areas for future annexation, it is a good time for the Commission to identify priorities for balancing the need to accommodate growth to meet the regional housing needs and expand economic development opportunities, while at the same time managing that growth with LAFCo's mandate to protect agricultural and open space resources. Similarly, the County to looking at General Plan amendments to expand opportunities for economic development in rural areas that are adjacent to regional transportation cooridors, but which often contain productive agricultural land.

### Action Requested

No action is requested from this continued discussion. The Commission may identify some future course of action based on the discussion, such as commenting on pending city and county development proposals, coordinating with the City of San Juan Bautista to initiate a sphere of influence update for the recently updated General Plan, and engaging with the City of Hollister as they initiate the General Plan update effort over the coming year(s). Other options could involve establishment of a subcommittee on agricultural preservation consisting of two members of the Commission, or investigating existing agricultural preservation policies of other LAFCo's in similar agricultural counties. Without initiating any more formal effort, the Commission may just want to monitor the efforts of the Cities and County as they address agricultural impacts during the environmental review (CEQA) process of individual projects and plans.
