GANN LIMIT - HISTORY

Proposition 4 created Article XIIIB of the California Constitution which provides a formula for calculating spending limit and also serves to:

- Places annual limits (or ceilings) on the appropriations of tax proceeds that can be made by the state, school districts, and local governments in California. These limits are based on the amount of appropriations in the 1978-79 "base" year, as adjusted each year for population growth and cost-of-living factors.
- Require state and local governments to return any funds to taxpayers in excess of the amount appropriated for a given fiscal year.
 - Require the state to reimburse local governments for the cost of complying with state

Subject: Price Factor and Population Information

Appropriations Limit

California Revenue and Taxation Code section 2227 requires the Department of Finance to transmit an estimate of the percentage change in population to local governments. Each local jurisdiction must use their percentage change in population factor for January 1, 2019, in conjunction with a change in the cost of living, or price factor, to calculate their appropriations limit for fiscal year 2019-20. Attachment A provides the change in California's per capita personal income and an example for utilizing the price factor and population percentage change factor to calculate the 2019-20 appropriations limit. Attachment B provides the city and unincorporated county population percentage change. Attachment C provides the population percentage change for counties and their summed incorporated areas. The population percentage change data excludes federal and state institutionalized populations and military populations.

Population Percent Change for Special Districts

Some special districts must establish an annual appropriations limit. California Revenue and Taxation Code section 2228 provides additional information regarding the appropriations limit. Article XIII B, section 9(C) of the California Constitution exempts certain special districts from the appropriations limit calculation mandate. The code section and the California Constitution can be accessed at the following website: http://leginfo.legislature.ca.gov/faces/codes.xhtml.

Special districts required by law to calculate their appropriations limit must present the calculation as part of their annual audit. Any questions special districts have on this requirement should be directed to their county, district legal counsel, or the law itself. No state agency reviews the local appropriations limits.

Population Certification

The population certification program applies only to cities and counties. California Revenue and Taxation Code section 11005.6 mandates Finance to automatically certify any population estimate that exceeds the current certified population with the State Controller's Office. **Finance will certify the higher estimate to the State Controller by June 1, 2019**.

Α. **Price Factor**: Article XIII B specifies that local jurisdictions select their cost of living factor to compute their appropriation limit by a vote of their governing body. The cost of living factor provided here is per capita personal income. If the percentage change in per capita personal income is selected, the percentage change to be used in setting the fiscal year 2019-20 appropriation limit is:

Per Capita Personal Income

Fiscal Year	Percentage change
(FY)	over prior year
2019-20	3.85

B. Following is an example using sample population change and the change in California per capita personal income as growth factors in computing a 2019-20 appropriation limit.

2019-20:

Per Capita Cost of Living Change = 3.85 percent Population Change = 0.47 percent

Per Capita Cost of Living converted to a ratio: <u>3.85 + 100</u> = 1.0385

 $\frac{0.47 + 100}{100} = 1.0047$ Population converted to a ratio:

Calculation of factor for FY 2019-20: $1.0385 \times 1.0047 = 1.0434$

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE **COUNTY OF SAN BENITO THAT:**

Recommended Budget. The Recommended Budget of the County of San Benito 1. for the fiscal year beginning on July 1, 2019 and ending on June 30, 2020, as submitted to the Board of Supervisors by the County Administrative Officer on June 14, 2019, and as later amended by the Board of Supervisors on June 24, 2019, upon conclusion of the budget hearing(s), is hereby approved as the legal authorization to spend until approval of the adopted budget in accordance with California Government Code 29064.

- 2. Expenditures. Expenditures of the County of San Benito for the 2019-2020 fiscal year, appropriations to reserves and contingencies, and inter-fund transfers shall be governed and controlled according to the amounts specified in the FY 2019-2020 budget appropriations attached to and made a part of this Recommended Budget Resolution. Expenditures shall be controlled at the object level. Major objects of expenditure include (a) Employee Salaries & Benefits, (b) Services & Supplies, (c) Cost Applied, (d) Other Charges, and (e) Fixed Assets.
- 3. New Positions & Capital Assets. Pursuant to Government Code Section 29124, the Schedule of Capital Improvements and Authorized Positions are appropriated and approved by the Board of Supervisors as the spending authority until the adoption of the adopted budget.
- 4. <u>June 30, 2019 Year-End Closing Adjustments.</u> The Auditor-Controller is directed to determine the actual year-end revenues, expenditures, fund balances, and amounts reserved and/or designated by purpose as of June 30, 2019 for each fund. Pursuant to Government Code Section 29125, the Auditor- Controller is authorized and directed to approve transfers and revisions of appropriations with a budget unit to clear any deficits at the object level that exist at the end of the fiscal year except that any transfers from contingencies is subject to approval by the Board of Supervisors. The Auditor -Controller shall report to the Board of Supervisors any amount adjusted as part of the year-end closing process no later than December 1, 2019.
- 5. <u>Appropriation for Contingencies</u>. Contingencies are appropriated in the amount of \$1,000,000 for all funds. The General Fund Contingency will be appropriated at \$1,000,000. Actual June 30, 2019 year-end fund balances by fund will be determined by the Auditor-Controller. The Auditor-Controller shall report to the Board of Supervisors any amounts adjusted as part of the year-end closing no later than December 1, 2019.
- 6. <u>Budget Transfers.</u> Pursuant to Government Code Section 29125, the County Administrative Officer and the Auditor-Controller, jointly, are authorized to approve budget transfers between objects within program budget units in the same fund up to \$25,000.
- 7. Adopted Budget. In accordance with Sections 29000 through 29093 of the California Government Code, the Board of Supervisors of the County of San Benito is required to adopt the 2019-2020 fiscal year budget no later than October 2, 2019 and thereafter the San Benito County Auditor must file a copy of the adopted budget in the format prescribed by the Controller with the Clerk of the Board and the California State Controller in the manner required by law not later than December 1, 2019.
