REGULAR MEETING MARCH 22, 2011 ACTION MINUTES

The Board of Supervisors of San Benito County met in the Board Chambers on the above date in *regular session*. Supervisors Barrios, Botelho, Rivas, Muenzer and De La Cruz were present. Also present were County Administrative Officer Rich Inman, County Counsel Matthew Granger, and Asst. Clerk of the Board Janet Slibsager. Chair Barrios presided.

9:00 a.m. CALL TO ORDER:

- a) Supervisor Botelho led the Pledge of Allegiance.
- b) Upon motion duly made, seconded and carried, acknowledged Certificate of Posting.
- County Public Works Departments and the road crews for their diligent efforts in keeping the roads open in spite of the heavy rains just before their National Hare Scrambles and National Youth Hare Scrambles on February 19th and 20th. Mr. Tobin also thanked the Board of Supervisors for making the decision a year ago to keep the roads open in the Clear Creek Management Area, despite the fact that the Bureau of Land Management had temporarily closed the area to recreational use. Mr. Tobin announced that the OHMVR Commission will be holding a meeting in Hollister on April 5th and 6th and encouraged the Board of Supervisors to participate to the best of their ability.

Esperanza Torres, Caregiver IHSS, spoke in regards to the Home Care Program and the cuts and how they would affect the clients in San Benito County.

Maria Gonzalez, Hollister resident, said that she is a single parent who receives in home care support and does not want to see anymore changes in home care program.

Maria Perez, Hollister resident, who also receives in home support care for her daughter who is in a wheel chair, said that she hopes that the Board of Supervisors would reconsider any cuts to this program.

Irma Rodriquez, SEIU program, asked that the Board of Supervisors make no cuts to this program, as these people who are in the program are not able to care for themselves.

Richard Bettencourt, Hollister resident, thanked the Board of Supervisors for putting the Board of Supervisors entire agenda on line for the public to view.

Marty Richman, Hollister resident, said that he opposes any Health Care cuts, it is a good program and is a good deal, and therefore he supports the program.

d) Department Head Announcements: Planning Director Gary Armstrong announced that he attended the yearly conference for the American Association of Environmental Professionals for the State and was proud to announce that our County and our Consultant Aspen Environmental won an award for the outstanding environmental analysis document for the Panoche Valley Solar Farm EIR.

Supervisor Botelho thanked the Planning Department and County staff for a great job and the award was well deserved.

Chair Barrios concurred with Supervisor Botelho

Deputy Director of Community Service & Welfare Development Enrique Arreola spoke of two events that were coming up: Employer recognition for the One-Stop Career Center on Thursday March 24th at San Juan Oaks from 8:00 a.m. to 9:30 a.m.; and the 10 Year Anniversary of the One-Stop Career Center at the One Stop Career Center on Thursday March 24th from 10:00 a.m. to 1:00 p.m.

e) Board Announcements, Introductions and Presentations: Supervisor De La Cruz announced that he attended the Council of Governments (COG) meeting, South County Housing meeting with the City of Hollister and a budget meeting with the CAO Rich Inman.

Supervisor Rivas spoke in regards to an issue he had read about in the Mercury News about an environmental disaster that has been brewing in South San Benito County at New Idria Mines. He said it has been reported that this is one of the Nation's worst polluted places. Supervisor Rivas voiced frustration as to why the San Benito County Board of Supervisors has not made it their top priority to clean this place up. Supervisor Rivas said that he has a lot of questions that need to be answered and would like to see this item agendized for a later board meeting in regards to the actions that have been taken by our county and the history of the New Idria Mines since he is a new Board member.

Supervisor Botelho announced that he attended a Council of Governments (COG) meeting. He also mentioned that he was asked to serve on the Monterey Bay Chapter selections committee for the hero's celebration for Monterey and San Benito County, which would be on May 14th at the Naval Post Graduate School.

Chair Barrios mentioned that she participated in the American Red Cross hero's nomination committee and that she attended Farm Day at Bolado Park.

Chair Barrios thanked Janelle Cox, Steve Wittry and the Parks and Recreation Commission for the community meeting they held in regards to input for the Regional Parkway area.

Chair Barrios said that she would like to have an item on the April 12th meeting in regards to discussion on the Clear Creek Management Area.

Supervisor Muenzer responded to Supervisor Rivas's concerns about New Idria Mines and asked that Integrated Waste Manager Mandy Rose provide a brief update.

Mandy Rose announced that there will be a public meeting on April 5th in the Board Chambers in regards to New Idria Mines.

Supervisor Rivas reported that he attended the Inter Governmental Committee and discussed illegal vendors in our County and they are currently studying the issue and will bring back information at a later date.

Chair Barrios provided additional information in regards to the illegal vendors and how they would be moving forward.
