SPECIAL MEETING AUGUST 18, 2011 ACTION MINUTES

The Board of Supervisors of San Benito County met in the Board Chambers on the above date in *regular session*. Supervisors Barrios, Botelho, Rivas, Muenzer and De La Cruz were present. Also present were County Administrative Officer Rich Inman, County Counsel Matt Granger, and Assistant Clerk of the Board Janet Slipsager. Chair Barrios presided.

ADMINISTRATIVE OFFICE – R. Inman:

- 1) **Hold a public hearing to discuss and give direction concerning supervisorial redistricting.**

Chair Barrios opened the public hearing.

CAO Rich Inman announced that the purpose of tonight's meeting was to get input from the public in regards to supervisorial redistricting.

Those speaking from the public were: Aurelio Zuniga, Hollister resident; Marvin Jones, Hollister resident; Jennifer Bagley, Hollister resident.

GIS Analyst Rene Ancheta provided a PowerPoint presentation in regards to the various options which were previously discussed by the Board of Supervisors.

Discussion ensued by Board and staff in regards to their options and changes that they would like to see made.

Mr. Ancheta provided those changes on the computer that were requested by the Board for the public to review. Mr. Ancheta would determine if those changes would work based on percentage and numbers.

Lengthy discussion continued by Board and staff in regards to changing the boundaries in all 5 districts to accommodate the request of the public and to meet the guidelines required for the redistricting.

Direction from the Board was to have Rene at GIS work with District 2 and District 4 boundaries to get it to come out right and bring those new maps back to the September 13th meeting for review.

CAO Rich Inman mentioned that an ordinance needs to be adopted by the Board of Supervisors by September 30, 2011 in order to meet the deadline requirements.

Supervisor Muenzer said that he did not concur with the last option presented.

Chair Barrios closed the public hearing.
