REGULAR MEETING ACTION MINUTES MAY 8, 2007

The Board of Supervisors of San Benito County met in the Board Chambers on the above date *in regular session*. Supervisors Monaco, Loe, Botelho, De La Cruz and Marcus were all present. Also present was County Administrative Officer Susan Thompson, County Counsel Dennis Le Clere and Clerk of the Board Linda Churchill. Chairman Don Marcus presided

9:30 a.m. CALL TO ORDER:

- a) Supervisor De La Cruz led the Pledge of Allegiance.
- b) *Upon motion duly made, seconded and carried, acknowledged certificate of posting.*

PRESENTATIONS / RECOGNITIONS:

 - 1) **Approved** proclamation declaring May 6 - 12, 2007 as "National Nurse Week" in San Benito County. (HHSA) *File #430*

- d) **Public Comment:** Tony Ruiz, local resident, came forward and expressed concern over the proposed site for the new Gavilan College Campus stating that the process has not been very transparent and he felt the views of the supervisors should be known to their constituents. Mr. Ruiz encouraged the

Board members and the public to attend the meeting to be held tonight (May 8, 2007) in the Board Chambers to hear input about this proposed site.

- e) **Department Head Announcements:** Curt Itson, Battalion Chief, Cal Fire, announced that it was Wildfire Awareness Week as declared by Governor Schwarzenegger, noting that fire season officially begins on May 14th at 8:00 a.m. Chief Itson encouraged the community to be aware of the high fire danger here in the county this year.

- f) **Board Announcements, Introductions and Presentations:** Supervisor De La Cruz commented with regards to Mr. Ruiz's public comment about the proposed Gavilan Campus site. Supervisor De La Cruz felt it should be closer to the west side of the city indicating that he would be attending the meeting that evening.

Supervisor Botelho reported that over the weekend he attended the Aromas Recreation Field groundbreaking ceremony and also a reception held at the Mairose home in San Juan Bautista supporting the St. Francis Retreat, which is well on its way to being re-built after the fire. Supervisor Botelho encouraged contributions to this facility that brings in over 7000 people during the year for various retreats, workshops, meetings and etc.

Chairman Marcus, who serves as the Chairman of the Pajaro River Watershed Flood Prevention Authority, reported that the Authority has made a strong effort to remind our legislature how extremely important and urgent the Pajaro River Flood Control Project is to the region.

CONSENT AGENDA:

Upon motion made by Supervisor De La Cruz and seconded by Supervisor Monaco, approved Consent Agenda Items 7, 8, and 10 and pulling Items 6 and 9 for discussion and also clarification of Items 11 and 11.1. (Unanimous)

AGRICULTURAL COMMISSIONER – P. Matulich:

- 6) **Approve two (2) letters of support for Senate Bill #311 regarding funding for Weed Management Areas and direct clerk to forward said letter to Senator Dave Cogdill and Senator Jeff Denham.**

Marvin Jones, local resident, came forward and spoke in favor of this state program and warned the Board not to use this as a precursor for another program like the Mosquito Abatement Program and then at some time having to tax the citizens.

BOARD ACTION: *Upon motion made by Supervisor Monaco and seconded by Supervisor Botelho, approved the two letters of support for Senate Bill 311 as recommended. (Unanimous) File #156.1*

- 8) **Approved** and **authorized** the Chairman to sign letter of concern regarding Senate Bill 68 and **directed** letter be sent to State Representatives. *File #156.1*

PUBLIC WORKS – J. Lo:

- 9) **Approve amendment No. 2 to the agreement with CM Pros, Inc. for construction management services, increasing agreement by \$250,000 for a total of \$750, 000.**

Lengthy question and answer period ensued regarding the Board's concern with the continued increase in the costs association with this agreement.

It was the consensus of the Board of Supervisors to prioritize this matter as a future agenda item for clarification and explanation by the Public Works Director.

BOARD ACTION: *Upon motion made by Supervisor De La Cruz and seconded by Supervisor Loe, approved Amendment No. 2 to the agreement with CM Pros, Inc. as recommended and authorized the Chair to sign the agreement. (Unanimous) File #105*

PLANNING DEPARTMENT – A. Henriques:

Request: Modification of Condition Of Approval 14(a), requiring certain roadway improvements on John Smith Road along the property's frontage, to allow deferment of said roadway improvements. Applicant/Appellant: Al Silva, Jr. Location: 4155 John Smith Road, Hollister, CA. (A request for continuance has been submitted by the appellant.)**

Byron Turner, Principle Planner, reported that the appellant has requested a continuance of this appeal noting that staff has no problem with the request.

Robbie Scattini, Hollister Motorcycle Rally Committee, introduced Seth Doultan of Horse Power Promotions who provided a report on the plans and status of the upcoming Hollister Motorcycle Rally. Mr. Doultan handed out car stickers and an informational post card.

Sheriff Hill provided background information noting that this will be a critical piece of drug suppression efforts.

- 14) **Review hearing officer selection and compensation process and adopt ordinance amending Chapter 19 of the San Benito County Code pertaining to Code Enforcement. (cont. from 4/24/07 mtg.)**

Art Henriques, Director of Planning, provided background information stating that a description of the proposed Hearing Officer qualifications and compensation was included in the Board's packet as previously requested.

BOARD ACTION: *Upon motion made by Supervisor Marcus and seconded by Supervisor De La Cruz, adopted **ORDINANCE NO. 816** AMENDING SECTION 19-6 OF CHAPTER 19, CODE ENFORCEMENT, OF THE SAN BENITO COUNTY CODE, TRANSFERRING THE RESPONSIBILITY OF ADMINISTRATIVE HEARINGS FROM THE COUNTY ADMINISTRATIVE OFFICER OR DESIGNEE TO A "HEARING OFFICER"; and directed staff to report back to the Board of Supervisors in six months as to how this system is working. (Unanimous) File #790*

- 15) **Receive update report on the General Plan progress and provide direction as necessary.**

Art Henriques, Director of Planning, reported that Phase One of the General Plan Update is underway with staff and consultant having completed a series of meetings with key stakeholders from the community and workshops for the general public and a countywide survey are being planned. It is hoped that Phase Two can begin in the fall.

INTERNAL SERVICES – R. Inman:

Rich Inman, Director of Internal Services, stated that this would be a milestone in adding another degree of sophistication to the county's personnel policies and procedures. Mr. Inman reported that this would be creating a standard that pretty much exists already within public agencies within the state and throughout the country.

BOARD ACTION: Upon motion made by Supervisor Monaco and seconded by Supervisor De La Cruz, tentatively approved the San Benito County Drug and Alcohol Abuse Policy and directed staff to bring back the policy for final approval after meeting and conferring with employee representatives.
