REGULAR MEETING APRIL 11, 2006 ACTION MINUTES

The Board of Supervisors of San Benito County met in the Board Chambers on the above date in regular session. Supervisors Monaco, De La Cruz; Botelho, Marcus and Loe were all present. Also present was County Administrative Officer Susan Thompson, Acting County Counsel Irma Valencia and Assistant Clerk Sally Navarez. Chair Pat Loe presiding when the following was had to wit:

9:30 a.m. CALL TO ORDER:

- a) Pledge of Allegiance led by Supervisor De La Cruz.
- b) Upon motion duly made, seconded and carried, **acknowledged** the Certificate of Posting.

PRESENTATIONS / RECOGNITIONS

c) Presentation of Certificates of Recognition to Ken Range following 11 years of service on the San Benito County Fish & Game Commission and 4 years of service on the Substance Abuse Advisory Board.

Supervisor Monaco asked Mr. Range to come forward and acknowledged the many years of service to the Fish & Game Commission, Substance Abuse Advisory Board, Williamson Act Board as well as serving as a Deputy Sheriff.

Ronald Rodrigues of the Fish & Game Commission, came forward and presented Mr. Range with a plaque as well. Mr. Rodrigues noted that Mr. Range has served this county in many capacities and wish he and his family well as they leave the State.

Supervisor Loe thanked Mr. Range for his dedication to this community and all other Fish & Game Commissioners present at the meeting.

d) **Public Comment:** David Nicolayson, local resident, concerned with recent news reports of potential large development projects, asked that there be a ballot measure put on the November election to uphold the 1% growth cap which is already in place.

CAO Susan Thompson indicated she would discuss the matter with Mr. Nicolayson and noted the Board of Supervisors will be holding a workshop the afternoon of the April 25, 2006 meeting to continue General Plan process discussions.

Chair Loe directed the CAO to meet with Mr. Nicolayson to discuss his concerns and related questions relative to this matter.

e) **Department Head Announcements:** CAO Thompson asked Assistant Director of Public Works, Pete Corn, to provide a storm update relative to county roads.

Mr. Corn indicated there were a lot of potholes and a few small slides being monitored. Mr. Corn indicated matters would improve once we have better weather.

Supervisor Botelho asked about the flooding at The Alameda and San Juan Canyon Road to which Mr. Corn indicated the cause was due to the property owner where the drainage ditch was didn't keep it clean, thereby causing debris buildup and flooding.

Supervisor Marcus commended all the Public Works staff for their hard work during this time and asked Mr. Corn to convey his thanks to all staff members.

Supervisor Monaco echoed Supervisor Marcus' comments as well.

Planning Director Art Henriques introduced Chuck Ortwein, Senior Planner and Evan Hill, Chief Building Official as the newest members of his staff.
