### REGULAR MEETING AGENDA JULY 5, 2005

The Board of Supervisors of San Benito County met in the Board Chambers on the above date in regular session. Supervisors Marcus, De La Cruz; Botelho; Loe and Monaco were all present. Also present was Acting County Administrative Officer Susan Lyons, Interim County Counsel Claude Biddle and Assistant Clerk Sally Navarez. Chairman Reb Monaco presiding when the following was had to wit:

### 9:30 a.m. CALL TO ORDER:

a) Pledge of Allegiance.

b) Upon motion duly made by Supervisor De La Cruz and seconded by Supervisor Botelho, **acknowledged** the Certificate of Posting.

c) **Public Comment:** Joe Thompson, Tres Pinos resident urged the Board to make the effort to attract businesses that are leaving the Gilroy area due to Union Pacific Railroad limiting train traffic in that area. Mr. Thompson indicated the City of Gilroy is converting old cannery sites to retail/residential facilities – two story buildings with retail shops on the lower floor and residential living on the upper floor. Due to the announcement of Union Pacific to limit train traffic, Mr. Thompson said he foresees that eventually railroad service will not be coming to San Benito County in the very near future and that needs to be prevented.

d) **Department Head Announcements:** Substance Abuse Program Administrator Marc Narasaki indicated that the Board had sent a letter to the State Department of Health & Human Services urging that Prop 36 funding be restored. Mr. Narasaki noted it was rumored that there would be limited monies available for the next fiscal year; however he received notification that the full amount will be funded for 2005/2006 as a result of the Board letter. Mr. Narasaki thanked the Board for their continued support.

e) **Board Announcements, Introductions and Presentations:** Supervisor Loe noted she would like to get a committee together to work with Department Heads to have an open house for the new County Administrative Officer.

Chairman Monaco agreed with Supervisor Loe and indicated he would work with Supervisor Loe on this matter.

Supervisor Marcus took the opportunity to thank Sheriff Curtis Hill for protecting the County during the July 4<sup>th</sup> Rally.

Supervisor Botelho concurred that law enforcement work in a professional manner Saturday evening when there was the potential an incident to get out of control. Supervisor Botelho felt all citizens should know what it takes for law enforcement to protect the community during such an event.

Supervisor Botelho also took the opportunity to thank Susan Lyons for her services as the Acting County Administrative Officer.

Chairman Monaco noted he would like to receive an agendized report from Sheriff Hill on the activities. He agreed there were some tense moments Saturday night but law enforcement handled the matter well.

Sheriff Curtis Hill indicated security for the rally was a joint effort of agencies. Under the Unified Command System, he, along with Police Chief Jeff Miller and CHP Captain Bob Davies collectively worked for the safety of the community.

Regarding the incident of Saturday evening, Sheriff Hill noted the placement of cameras set up downtown have paid for themselves and all of the hard working law enforcement made it possible for safe event.

Chairman Monaco also commended Susan Lyons for her services as Acting CAO.

Action Minutes

Supervisor Botelho indicated he had the opportunity to view the documentary and felt it was important to support this item. Supervisor Botelho indicated Ms. Jennifer Roybal-Marquez, Keith Medlin of Seal Rock Inc. and Sheriff Curtis Hill have been invited to Washington, D.C. to present the video to national figureheads such as MADD.

Jennifer Roybal-Marquez, President of Seal Rock Inc. came forward. Ms. Roybal-Marquez indicated she would like to show the 15-minute version of the film and presented said clip.

Supervisor Botelho commended Ms. Roybal-Marquez and Mr. Medlin for their presentation. Supervisor Botelho felt it was necessary to show the film and its impact especially since the subject matter was directly related to underage drinking and its fatal consequences on our community.

**BOARD ACTION:** Upon motion duly made by Supervisor Botelho and seconded by Supervisor Marcus, **approved Resolution No. 2005-75 In Support Of The Project "Under The Influence And Under 21."** Motion passed unanimously.

Supervisor Loe thanked Ms. Roybal-Marquez and Mr. Medlin for their hard work on this project and hoped the visual imagery will help to drive home the message home of the consequences of drinking and driving among the young people.

Supervisor De La Cruz also agreed the presentation was vital for the young people as one of his nephews was involved in such a tragedy and noted these circumstances destroy families. Supervisor De La Cruz agreed if this film helped save one life, it was worth it.

Supervisor Marcus agreed with Supervisors Loe and De La Cruz. Supervisor Marcus indicated the impact is felt much more by the residents of a small community such as San Benito County and wished them well on the trip to Washington, D.C. *(file #156)*

Mr. Machado thanked the Board for the Recognition and noted he was late due to working on items on his desk. Mr. Machado indicated he would miss those he had come into contact with through the course of his tenure with the County.

Ag Commissioner Paul Matulich came forward. Mr. Matulich indicated in accordance with Sections 2272 and 2279 of the California Food and Agricultural Code, this report is ready for release pending acceptance from the Board of Supervisors. Mr. Matulich concluded by stating the report will be made available to the public on the Ag Commissioner's website upon Board acceptance and approval.

Discussion ensued regarding agricultural and livestock production continue to be the mainstay of the county.

**BOARD ACTION:** Upon motion duly made by Supervisor Marcus and seconded by Supervisor De La Cruz, **accepted** the 2004 Crop Report from Ag Commissioner Paul Matulich and **authorized** release of said report to the public via the Ag Commissioners web-site. Motion passed unanimously. (file #1.1)

Interim County Counsel Claude Biddle noted this request to allow the third party claims administrator, George Hill Company on behalf of the County if said claims are under \$20,000.

Discussion ensued regarding if the Board would be kept appraised of proposed settlement of claims prior to the George Hills Company to which Counsel Biddle indicated the Board would be appraised before and following the settlement of any claim.

**BOARD ACTION:** Upon motion duly made by Supervisor Marcus and seconded by Supervisor Botelho, **approved Resolution No. 2005-76 Authorizing the contract third party administrator to reject, settle, compromise or approve claims filed against the County of San Benito**. Motion passed unanimously. (file #36)

### ADMINISTRATIVE BUSINESS:

### 26) Receive update regarding San Benito County's adopted Housing Element. (Acting CAO)

Discussion was held with input from Interim Planning Director Michael Bethke, Acting CAO Susan Lyons and members of the Board.

Discussion included reviewing whether or not the City of Hollister has an inclusionary housing ordinance, how it compares with the County of San Benito ordinance, what are surrounding counties are implementing, is there a need to amend the existing ordinance in January of 2006, etc.

## 27) Hold discussion regarding employee appreciation activities and provide direction. (Acting CAO)

Ms. Lyons indicated there was an appreciation barbecue for the employees and it was received well. She felt the dedication of the employees needed to be recognized and would like to see an annual barbecue structured around a safety program since there were monies available for safety programs from last year. Ms. Lyons noted that the Department Heads and Board of Supervisors members would serve the employees.

Chairman Monaco questioned the monies left from last year and were those monies rolled over.

Ms. Lyons indicated that was correct, the monies were rolled over into the General Fund and this years' estimated cost would be around \$3500.

Chairman Monaco indicated he was involved with the event last year and felt it was a great idea to coordinate the event into a safety program. Chairman Monaco also felt the event should be held on a Saturday to allow employees and their families to attend.

Chairman Monaco indicated he and Supervisor Loe would work with staff on coordinating this event.

Supervisor Loe agreed this was a good idea and would serve with Chairman Monaco.

Supervisor De La Cruz stated this was a great idea and it didn't involve taxpayer monies and use of safety monies could help reduce health care and workers comp costs.

Supervisor Marcus noted it was important to recognize staff for their team efforts and would like to see a date specific set. Supervisor Marcus noted he would like each Board member to donate \$200 for said the barbecue and indicated he would be providing his donation right away.

**BOARD DIRECTION:** Chairman Monaco indicated he and Supervisor Loe would be working with Acting County Administrative Officer Susan Lyons on the coordination of this event.

Chairman Monaco took the opportunity to thank Susan Lyons for her services to the Board during the Interim period.

Supervisor De La Cruz also commended Ms. Lyons for being supportive and helpful to him as well during her serving as the Acting County Administrative Officer. *(file #630)*
