ACTION MINUTES

The Board of Supervisors of San Benito County met in the Board Chambers on the above date in regular session. Supervisors Loe, Monaco, Kesler and Cruz were present. Supervisor Scagliotti was absent. Also present was Interim County Administrative Officer Gil Solorio, County Counsel Karen Forcum and Senior Board Clerk Linda Churchill. Chairman Cruz presided.

9:30 a.m. CALL TO ORDER:

- b) Upon motion duly made, seconded and carried, acknowledged Certificate of Posting.
- Public Comment: Henry Sumaya, Hollister resident, came forward. Mr. Sumaya stated that he wanted to respond to an article in the local newspaper with regards to himself and other people regarding a meeting with Nativo Lopez, who belongs to a Mexican national organization in Los Angeles, which was attended by Chairman Cruz, Supervisor Loe and City Councilman Brian Conroy. Mr. Sumaya said this concerned him because basically we are beating a dead horse and he thought that the District Attorney was taking care of the problem - if there was a problem. Mr. Sumaya indicated that he had been in touch with two attorneys and with legal counsel of the Mexican-American Political Association and he felt the public deserves an answer to what happened and he would be turning over his letter from Nativo Lopez to the newspaper.

Chairman Cruz cautioned Mr. Sumaya about mentioning names of persons who were not present at the meeting today. Chairman Cruz stated that while he did meet with Nativo Lopez he had nothing to do with Mr. Lopez coming here.

Supervisor Kesler suggested that Mr. Sumaya should go to the media and that it was not appropriate for him to come before the Board of Supervisors with regards to this matter.

Ruth Nordstrom, Hollister resident, reported there would be a meeting held tonight regarding the proposed Indian Gaming Casino. Ms. Nordstrom said they were working on getting the public informed about this issue and also getting the word out about the October 21st meeting sponsored by the Board of Supervisors to be held at the Veteran's Memorial Building. Ms. Nordstrom asked if there was a way to get the word out more with regards to the meeting.

Chairman Cruz stated that the County has sent out over 100 letters inviting all of our neighbors such as supervisors and city council members. Chairman Cruz noted that he and Supervisor Loe requested that Sheriff Hill invite someone from a Sheriff's Department in a county that already has a casino to be one of the speakers October 21st and Supervisor Loe is going to contact Congressman Sam Farr's office to see if we can get someone from an Indian tribe to come in and talk to us about bringing in an Indian Gaming casino.

Supervisor Monaco noted that the Board of Supervisors had not taken a position on the Indian Gaming Casino nor can they at this point. We are still in the stage of investigating and trying to gather as much information as we can about the impact of gaming casinos in communities.

Laura Lee Foote, San Juan Bautista resident, came forward. Ms. Foote stated that she has sent letters of endorsement to the San Juan Bautista City Council and others and she has received endorsements from Council Members and others in San Juan Bautista who are fighting against this casino with her.

d) **Department Head Announcements:** Pat Johns, University of California Cooperative Extension, came forward. Ms. Johns presented Supervisor Monaco with a plaque for his participation in the Kiss a Pig Contest since he was not able to be present at the fair.

Ms. Johns reported that the Kiss a Pig Contest brought in \$8233.00 and the pig sold for \$10,600.00 for a grand total of \$18,833.00 which means that they reached and exceeded their goal for the local 4-H program.
