SHERIFF'S OFFICE - D. Thompson:

1) Accept and approve the Sheriff's Staffing Plan for the new courthouse, including position classifications; and accept and approve a one-time contribution of \$100,000 from the Court for the specific and limited purpose of funding Security Services at the new courthouse; and direct the County Administrative Office to deposit the Court's one-time contribution of \$100,000 so that any unexpended funds are carried forward into the subsequent fiscal year with the same specific and limited purpose of funding Security Services at the new courthouse; and accept and approve the MOU for Security Services at the new courthouse and authorize the Chair to sign the MOU; and direct the sheriff to provide an update to the Board of Supervisors by July 1, 2014 with regard to the status of permanently increasing the State's funding for Security Services.
