CAO Espinosa asked Kevin O'Neill, OES Manager, to present the item to the Board on behalf of the Administration.

Mr. O'Neill introduced Mr. Larry Smith, Lead Meteorologist and Storm Ready Program Manager with the National Weather Service to address the Board.

Mr. Smith indicated that his office had been working very closely with Kevin O'Neill and offered his congratulations on the designation of being Storm Ready on behalf of the National Weather Service.

Supervisor Anthony Botelho commended the OES Department and asked if any steps had been taken to address heat-related emergency related to the weather that involved Senior Citizens with San Benito County.

Director O'Neill indicated that the Storm Ready Program included preparations for these types of emergencies.

Sheriff Thompson announced that this evening is National Night Out which occurs the first Tuesday in August of each year.

CAO Espinosa reminded the Board that next Tuesday, August 11, 2015 is the Board of Supervisor Retreat which is a continuation from the February Retreat Session.

The Chair congratulated the new Fire Chief.

#### **COUNTY ADMINISTRATIVE OFFICE – R. Espinosa (Page 244)**

15) Introduction of New City of Hollister Fire Chief, Hollister Fire Update and Fire Recovery USA Presentation – Bridgette Bugbee, West Coast Regional Account Manager regarding cost recovery efforts related to emergency calls.

CAO Espinosa invited the newly appointed City of Hollister, CA Fire Chief, Martin Del Campo, to address the Board and to provide a report to the Board. The record shall reflect that San Benito County procures fire services under contract from the City of Hollister, CA.

The Chief reported significant problems related to the drought and many wildfires throughout the State of California. Locally, the City of San Juan Bautista, CA also experienced a fire that was extinguished by the fire services while maintaining a Continuity of Service to the rest of the County.

The Chief then introduced Bridgette Bugby from Fire Recovery USA. She described her firms cost recovery services to the County.

After extensive discussion regarding the proposed services, the CAO was instructed to bring a complete discussion item related to this topic back to the Board on a future meeting agenda.

Mr. Marty Richman, Resident of the City of Hollister, CA, opined that the entire presentation was baloney and took strong issue with the merits of such an effort.

Mr. Marvin Jones echoed Mr. Richman's comments.

At the conclusion of the discussion regarding the topic of financial recovery services, the entire Board offered their congratulation to the new fire chief and wished him the best of luck.

There was no formal action taken on this item by the Board.
