6. Consideration of Exemption from LAFCO Review Under Government Code Section 56133(e)(4) for continuation of sewer service from the City of Hollister to a "HEAP" grant-funded homeless housing project consisting of 5 prefabricated small residences located at the County Migrant Farm Labor Housing project site at 3235 Southside Road (Assessor's Parcel Number 020-300-030). The project is proposed by the San Benito County Health & Human Services Agency.

Executive Officer Bill Nicholson provided background information on the current county migrant farm labor housing project, known as HEAP. LAFCO Review is needed for the city to provide sewer connection to a project that extends outside of city limits.

This project is exempt from LAFCO review because sewer service was in existence prior to 2001, and there is no increase in demand for sewer.

Commissioner Velasquez is alright with this. Commissioner Flores and Tiffany had no comments. Commissioner Bettencourt wanted to know if the county can use the vacant RV areas in the future.

Mr. Nicholson responded that for each homeless unit, an RV space will remain vacant.

Public Comment: Comments in support of housing were provided by Elia Salinas.

Commissioner Tiffany made a motion to approve the exemption from LAFCO Review for the 5 prefabricated small residences located at the County Migrant Labor Housing project, seconded by Commissioner Bettencourt.

7. First amendment to the Contract for Executive Officer Services adding a cost-of-living adjustment provision.

Executive Officer Bill Nicholson provided background information on an addition of a cost-of-living adjustment for the contract for Executive Officer Services. This item was brought up last year and was continued based on the COVID crises.

The cost-of-living increase would be reviewed each year based on the consumer price index.

Commissioner Tiffany believed it was a reasonable approach.

Commissioner Flores believed it is time.

Commissioner Velasquez believed Mr. Nicholson deserves the increase.

Commissioner Medina concurred with the other commissioners and had no issues with this item.

Public Comment: Elia Salinas summarized past billing and questioned how Executive Officer's time is calculated.

Commissioner Velasquez brought up the role of alternate commissioners speaking or participating during public comment based on past commission action.

Mr. Gallogly provided background information on alternate board members and speaking during public comment.

There was a discussion between the Commissioners on previous discussions regarding alternates and the LAFCO bylaws.

Mr. Nicholson provided background information on bylaws regarding alternates attending meetings and discussing items. Alternates can speak during public comment but not as a commissioner, only as a member of the public.

Commissioner Medina requested that a copy of the bylaws be forwarded to him by Mr. Nicholson.

Mr. Nicholson agreed to forward a copy to Mr. Medina and all the LAFCO Commissioners.

Commissioner Velasquez made a motion to approve the First Amendment to the contract for Executive Officer Services adding a cost-of-living adjustment provision, seconded by Commissioner Bettencourt

8. Discussion of upcoming Budget Process and Work Program for Fiscal Year 2021-22.

Executive Officer Bill Nicholson provided background information on the budget process. The Commission needs to adopt a preliminary budget and provide it to the cities and all special districts because LAFCO is funded 50% by cities and 50% by the county. We will need to bring back the Final Budget to the April meeting after feedback. We then have to adopt budget by June 15th.

Mr. Nicholson mentioned that completion of a Municipal Service Review of the County Service Area (CSAs) was delayed, and he would recommend this continue for next year's work program. Mr. Nicholson also discussed the process for the review of sphere of influence. Would not recommend LAFCO initiate either municipal service review (MSR) or a sphere of influence but let cities propose them first, as they are both working on it now.

Commissioner Bettencourt asked if MSR's are not completed every five years if LAFCO can get fined.

Mr. Nicholson responded that there is not a fine.

Commissioner Bettencourt asked that Hollister paying 93% of the city half portion for LAFCO funding be discussed during the budget discussions.

Commissioner Velasquez agreed it should be discussed during that meeting.

Commissioner Tiffany agreed looking at the CSA's and asked if Sunnyslope Water District MSR should be updated.

Mr. Nicholson responded that it may be premature to update it now without knowing what water services the City of Hollister will be needing based on their pending General Plan update. Sunnyslope could wait until we complete the City's sphere of influence update.

Commissioner Flores had no comments.

Public Comment: David Early, Consultant of the City of Hollister General Plan Update gave a status report. Elia Salinas requested LAFCO investigate forming a sewer district and possibly a water district.

Mr. Nicholson explained that the laws governing LAFCO determine where the funding comes from. San Benito County does not have special districts, so the two cities pay half the funds according to their total revenue and the county pays the other half.

No action taken.

9. Commission direction on whether to initiate a Sphere of Influence Amendment for the City of Hollister in the Southside Road Area (12-month review requested at the February 19, 2020 Commission Meeting).

Executive Officer Bill Nicholson provided background information and an update for several projects being processed by the City of Hollister. Annexation or future annexation needs to be within the City's Sphere of Influence. The City is working on their proposed sphere, but it will be reviewed and ultimately approved by LAFCO. No new applications have been filed in the area, so no rush on moving forward with this amendment.

Commissioner Velasquez explained that the General Plan for Hollister is close to being completed and suggests this be moved to 2022.

Commissioner Tiffany asked Mr. Velasquez when during 2022 he expects the General Plan to come out.

Commissioner Velasquez expressed that he is looking forward to the completion of the General Plan to be in 2022 and Mr. Early could further elaborate on that.

Commissioner Flores had no comment.

Commissioner Bettencourt agreed with Commissioner Tiffany to wait for the General Plan to be completed and asked Mr. Nicholson if there are any concerns if nothing is done until the General Plan is completed.

Mr. Nicholson explained that he would always recommend the commission move the sphere for an urban service extension like sewer service, and for urban development that should be in the sphere of influence of the city.

Public Comment: David Early commented that the General Plan Update is also looking at the sewer service issue for Hollister and the surrounding area.

Direction was to not reinitiate a Sphere of Influence Amendment for the City of Hollister in the Southside Road Area and wait for the General Plan to be completed.

Commissioner Tiffany, Flores, and Medina had no announcements or requests.

Commissioner Velasquez would like to revisit the alternates participating in the meetings.

Dear Members of the Commission:

RECOMMENDATION

It is recommended the Commission:

- 1. Review the Proposed Budget for Fiscal Year 2021-22, accept all public testimony and approve the Proposed Budget with any desired modifications.
- Direct the staff to distribute the Proposed Budget to cities, special districts and the 2. County as required by Government Code Section 56381.
- 3. Return to the Commission with a Final Budget for consideration at the May 13, 2021 regular Commission meeting, scheduled at 6:00 pm.

DISCUSSION

Attached to this Report is a summary of the Proposed Budget for Fiscal Year 2021-2022 "Explanation of Accounts" which also identifies the appropriations and expenditures experienced through March 31st in the current 2020-21 Fiscal Year. As a short summary, as of the end of March, the Commission had expended \$48,586 of the full year's budget of \$151,518 (representing approximately 32%). The next Fiscal Year budget is proposed to decrease slightly to a total of \$149,579.

As detailed in the Explanation of Accounts attachment, current fiscal year expenditures are well below budgeted amounts in several accounts - notably accounts related to processing of boundary change applications: services and supplies, legal notices, and consultant (Executive Officer) and Clerk service costs. We don't have current year invoices from County Counsel and there were no expenditures for conferences and travel due to the cancelled conferences from the COVID-19 pandemic. A copy of the "Budget Performance Report" for the 7/1/20 to 3/31/21 time period is provided as an attachment which highlights

expenditures and revenues by account number. This report doesn't necessarily show all transactions through March 31st, and in the first attachment: "Explanation of Accounts" bills received by March 31st, but not yet paid are reflected in the individual account totals.

Revenue from application fees totaled \$1,840.00 in the first three quarters (reflecting one annexation and one out of agency boundary service request). However, there is one recent application submitted that is not reflected and two pending in the next month or two which could increase the total revenue to \$5,000 or more. Non-application revenue for LAFCO operations comes from mandatory contributions from the County and the Cities of Hollister and San Juan Bautista, and billing by the County Auditor doesn't typically occur until near the end of the Fiscal Year.

Summary of the Budget Process

LAFCO is an independent commission established by the legislature to carry out specific duties. It is responsible for adopting its own budget to fulfill the purposes described in the Cortese/Knox/Hertzberg Local Government Reorganization Act of 2000. The law does not require approval of the budget by the County, the cities or any other local agencies beyond the LAFCO Commission itself.

Government Code Section 56381(a) governs the preparation of the LAFCO budget. It reads as follows:

The commission shall adopt annually, following noticed public hearings, a proposed budget by May 1 and final budget by June 15.

At a minimum, the proposed and final budget shall be equal to the budget adopted for the previous fiscal year unless the commission finds that reduced staffing or program costs will nevertheless allow the commission to fulfill the purposes and programs of this chapter.

The commission shall transmit its proposed and final budgets to the board of supervisors, to each city, and to each independent special district.

Slight Proposed Budget Decrease

There are several recommended changes in the Proposed Budget from the current fiscal year that, in total, would decrease requested appropriations by a total of \$1,939. This has to do with recalculating the anticipated hours to be spent by the Executive Officer in support of LAFCO functions. Time is typically based on 35 hours allocated per month, and there is a proposed continuation of a special project with the County that got delayed: an update to the County Service Area (CSA) municipal service review estimated at 50 hours.

However, in last year's budget, older projects which had been completed still were included in the time estimate but are no longer necessary. The cost is still lower, even when accounting for an estimated consumer price index (CPI) increase approved by the Commission at the March 11, 2021 meeting, which is estimated at 2.5% (amounting to an additional \$1,645 if all 490 hours are worked in the coming Fiscal Year).

This saving is partially offset by increases in the California Association of Local Agency Formation Commissions (CALAFCO) dues being increased by \$46 based on the County's population increase, an increase in the GIS Service account of \$620, and an increase in advertising costs to be prepared for an anticipated increase in public hearing items next Fiscal Year.

The Commission may wish to make further modifications to this Proposed Budget based on a review the attached Proposed Budget "Explanation of Accounts" and comments by the Commission or public at the scheduled public hearing.

However, the Commission should be aware that appropriations which are not expended during one fiscal year become part of the Available Fund Balance to finance the following fiscal year budget. These "carry over" funds reduce the amount requested to be paid by the County and Cities. The Auditor's Office computes any fund balance at the end of the fiscal year.

Revenues

Contributions from the County and cities represent the great majority of LAFCO revenue. At the Proposed Budget Hearing, the Executive Officer will provide an update as to what these jurisdictions have paid in the prior fiscal year. Application fee revenue amounted to \$1,840.00 in the first three quarters, which is historically very low, although \$1,120 has recently been submitted for the Rosati Annexation to Hollister and two or three other application are anticipated by the end of the Fiscal year which could raise this total to over \$5,000.00. With the City of Hollister General Plan update underway and efforts by the City of San Juan Bautista to identify a preferred sphere of influence, application activity, and corresponding revenue, is expected to increase in the next fiscal year.

REQUESTED ACTION

In consideration of this information, it is recommended the Commission adopt the Proposed Budget and direct the Executive Officer to distribute it to local agencies as required by Government Code Section 56381(a), incorporating any amendments desired by the Commission. The Commission should also set a public hearing on the Final Budget for the regularly scheduled Commission meeting on May 13, 2021.

The California Association of Local Agency Formation Commissions (CALAFCO) has sent out a request to all LAFCOs requesting letters of support for an annual "omnibus bill" which provides minor technical or procedural changes to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (the Act) which governs LAFCO activities. Our professional association, CALAFCO, works closely with the Assembly Local Government Committee to author these omnibus bills, and the proposed technical changes to the Act come from professionals from local LAFCOs - with the requirement they be non-substantive changes and noncontroversial.

This year's list involves the following proposed amendments to the Act (and the Bill is attached):

- 1) Clarify that LAFCO is responsible to periodically adopt, amend or "update" speheres of influence of local agencies, and removes the word "revise" as a periodic "update" is how the law is currently worded; and
- 2) Clarify that the LAFCO in the county where a service is going to be extended outside the agency's boundary (city or special district) is responsible to process the extension request rather than the LAFCO in the county where the service comes from; and
- 3) Would exempt dissolved inactive special district from tax sharing negotiations.

It is not likely that most of these provisions will impact San Benito LAFCO except for special districts - including County Service areas (CSAs) - which are dissolved under a streamlined process being exempted from the tax sharing negotiations is a benefit since 11 CSAs were recently dissolved through this process.

An act to amend Sections 56133, 56427, and 56879 of, and to amend and renumber Section 56325.1 of, the Government Code, relating to local government.

LEGISLATIVE COUNSEL'S DIGEST

AB 1581, as introduced, Committee on Local Government. Local government: omnibus.

Existing law, the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, provides the authority and procedure for the initiation, conduct, and completion of changes of organization, reorganization, and sphere of influence changes for cities and districts, as specified. Existing law requires a local agency formation commission to develop and determine the sphere of influence of each city and each special district within the county and enact policies designed to promote the logical and orderly development of areas within each sphere. Existing law requires the commission, in order to prepare and update spheres of influence in accordance with this requirement, to conduct a service review of the municipal services provided in the county or other appropriate area designated by the commission, as specified.

Existing law requires the commission to adopt, amend, or revise spheres of influence after a public hearing called and held for that purpose.

This bill would revise and recast that provision to provide that the commission is required to adopt, amend, or update spheres of influence after a public hearing called and held for that purpose.

AB 1581 — 2 —

Existing law authorizes a commission in the county which an extension of service is proposed to approve (1) a city or district to provide new or extended services by contract or agreement outside its jurisdictional boundary in writing, (2) a city or district to provide new or extended services outside its jurisdictional boundary but within its sphere of influence in anticipation of a later change of organization, and (3) a city or district to provide new or extended services outside its jurisdictional boundary and outside its sphere of influence to respond to an existing or impending threat to the health or safety of the public or the residents of the affected territory if specified conditions are met.

This bill would revise and recast those provisions to remove the general requirement the commission must be in the county which an extension of service is proposed and provide that a city or district may provide new or extended services by contract or agreement outside its jurisdictional boundary only if it first requests and receives written approval from the commission of the county in which the affected territory is located.

Existing law requires the commission to dissolve inactive districts and provides that dissolved districts are not subject to specified provisions.

This bill would add that dissolved districts are not subject to specified taxation provisions related to jurisdictional changes.

This bill would make other nonsubstantive changes.

- (1) The entity applying for approval has provided the commission with documentation of a threat to the health and safety of the public or the affected residents.
- (2) The commission has notified any alternate service provider, including any water corporation as defined in Section 241 of the Public Utilities Code, that has filed a map and a statement of its service capabilities with the commission.

- (1) Two or more public agencies where the public service to be provided is an alternative to, or substitute for, public services already being provided by an existing public service provider and where the level of service to be provided is consistent with the level of service contemplated by the existing service provider.
 - (2) The transfer of nonpotable or nontreated water.
- (3) The provision of surplus water to agricultural lands and facilities, including, but not limited to, incidental residential

structures, for projects that serve conservation purposes or that directly support agricultural industries. However, prior to extending surplus water service to any project that will support or induce development, the city or district shall first request and receive written approval from the commission in the affected county.

- (4) An extended service that a city or district was providing on or before January 1, 2001.
- (5) A local publicly owned electric utility, as defined by Section 9604 of the Public Utilities Code, providing electric services that do not involve the acquisition, construction, or installation of electric distribution facilities by the local publicly owned electric utility, outside of the utility's jurisdictional boundary.
- (6) A fire protection contract, as defined in subdivision (a) of Section 56134.
- 15 (f) This section applies only to the commission of the county 16 in which the extension of service is proposed.
 - SEC. 2. Section 56325.1 of the Government Code is amended and renumbered to read:

56325.1.

- 56331.4 While serving on the commission, all commission members shall exercise their independent judgment on behalf of the interests of residents, property owners, and the public as a whole in furthering the purposes of this division. Any member appointed on behalf of local governments shall represent the interests of the public as a whole and not solely the interests of the appointing authority. This section does not require the abstention of any member on any matter, nor does it create a right of action in any person.
- SEC. 3. Section 56427 of the Government Code is amended to read:
- 56427. The commission shall adopt, amend, or revise update spheres of influence after a public hearing called and held for that purpose. At least 21 days prior to the date of that hearing, the executive officer shall give mailed notice of the hearing to each affected local agency or affected county, and to any interested party who has filed a written request for notice with the executive officer. In addition, at least 21 days prior to the date of that hearing, the executive officer shall cause notice of the hearing to be published in accordance with Section 56153 in a newspaper of general circulation which is circulated within the territory affected

At the March 11, 2021 Commission meeting, there was a discussion about the role of alternate members of the Commission during a Commission meeting when the regular voting member is present. The Exceutive Officer briefly indicated that the "bylaws" (formally contained in the Rules and Procedures in the Commissioner Handbook) were modified several years ago to limit the participation of alternate members during the meeting. As a result, alternates would have the same rights as members of the public and the same opportunities to participate during meetings as provided for during public comment periods.

Chair Medina directed that Staff and Counsel look into this matter and place it on the next agenda for information.

At the June 8, 2017 regular Commission meeting, the Commission took action on a 4-1 vote to modify the Rules and Procedures, in Chapter 3, Section C.2. to read:

"Alternate members my not participate in LAFCO proceedings except in the absence or disqualification of a regular member."

A copy of the Resolution approving this change to the Commission's Rules and Procedures, as contained in the Commissioner Handbook is attached along with the page from the June 8, 2017 Meeting Minutes where the action was taken under Agenda Item No. 7.

Requested Action

At the recent March 11th Commission meeting, the Chair directed that this subject be placed on the next Commission agenda, but there was no direction from the Chair or vote by the Commission for any change to the current rules. Therefore, this item is only presented as an informational item. and no action is requested by the Commission. However, if any modifications or amendments are proposed, this issue could be set on a future agenda for a formal amendment.

WHEREAS, at the June 8, 2017 regular meeting, the Commission determined that the alternate members should not be encouraged to attend or participate in Commission meetings where the regular member is present and able to vote on the scheduled agenda items.

6. Adoption of Final Fiscal Year 2017-2018 Budget (Public Hearing Continued from May 25, 2017 Meeting.)

Executive Officer Nicholson provided testimony as to the budget hours that were originally projected for his position as Executive Officer. 7. Adoption of resolution changing Policies and Procedures in the LAFCO Commission Handbook allowing Alternate Commissioner participation at Commission meetings only when a Regular Commissioner is absent or disqualified from voting.

Executive Officer Nicholson provided summary testimony as to whether or not the language in the LAFCO Handbook should be modified to reflect the fact that Alternative Commissioners" may participate as citizens, and exercise normal citizen rights, in any LAFCO Commission meeting, rather than discouraging their rights as citizens.
