## Regular Agenda:

- 1. The meeting minutes of March 5, 2020 were approved.
- 2. Traffic Calming on Central Avenue Public Art--School/Community Partnership: Hollister Councilmember Rolan Resendiz spoke to the Committee about ongoing traffic concerns on Central Avenue, and shared a possible opportunity to address traffic problems by partnering with the Calaveras P.T.O. Collective in a public art project. Ms. Rosalinda Sanchez, President of the Calaveras P.T. O. Collective Calaveras explained that the group has facilitated community public art projects before. The process would be to collect art created by the school's students and submitted for the project, and forward that to a graphic design artist who would use it to create neighborhood branding. This branding would then be available for use as art in neighborhood crosswalks and perhaps other areas around Calaveras Elementary and Middle School as a traffic calming mechanism. San Benito County Superintendent of Schools Krystal Lomanto expressed her support of the program as did San Juan Bautista Councilmember John Freeman.
- 3. Traffic Mitigation Measures in front of HDLA: Tabled until next month.
- 4. Planning/Development School Mitigation Process: San Benito County Superintendent of Schools Krystal Lomanto addressed the Committee regarding mitigation measures for school impacts during the development process. She expressed the importance of timing, to insure that school concerns are addressed in the development process before the project moves forward. Hollister Mayor Ignacio Velazquez spoke about the importance of making sure schools have the opportunity to communicate their needs with the developer before City Council authorizes the tentative map. Hollister School District Trustee Jan Grist shared that she does not believe development fees are sufficient enough to build new schools amd San Benito High School Superintendent Shawn Tennenbaum agreed. The Committee discussed possible funding through Mello Roos districts or community facilities districts (CFD's). Superintendent Tennenbaum shared that developers only have to pay level 2 developer fees as set by the State but that these funds are not adequate. Mayor Velazquez stated that, as a group, all agencies should pursue CFD's as a way of securing school mitigation fees.
- 5. Regional Climate Action Plan Presentation: Benjamin Ikert, Director of Green Power, provided a presentation to the Committee regarding regional climate change policy and renewal energy policy throughout the central coast region. Mr. Ikert stated that climate change is currently in crisis and is not going away. He stated that it is important that we begin taking steps and initiating policy to significantly reduce carbon emissions and address the challenges that come with climate change. As we work towards being carbon neutral. Action plans identify processes to meet the State mandates. Our neighboring cities of Santa Cruz, Watsonville and Salinas have begun setting aside funds in fiscal year 2020/2021. San Juan Bautista Councilmember John Freeman shared that he is a long-time advocate for climate change and that he would like to see about joint plans with the City of Hollister and County of San Benito, indicating that there

may be some saving with regional projects and economies of scale. San Benito County Supervisor Peter Hernandez shared that he was supportive of saving the environment but was concerned about the financial commitment, as San Benito County is currently focused on meeting the needs of the pandemic. Hollister Councilmember Rolan Resendiz stated that he is also supportive of the environment but was also cautious as to the cost at this time.

- 6. Census 2020 Status: San Benito County Management Analyst Dulce Alonso provided a status update for the 2020 Census, which officially began on April 1, 2020. She indicated that San Benito County received some funding from the State in the amount of 81,000 to assist with outreach to hard-to-count populations, and that San Benito County was partnering with the Youth Alliance, the Community Foundation and United Way. Management Analyst Alonso also shared that the pandemic is creating difficulty in trying to reach out without person to person contact but that she was partnering with school districts and other organizations to get information to student families. Per the current calendar, census data will be collected until July 31. The Census Bureau will send redistricting information to State on March 31, 2021.
- 7. Committee Member Reports: Superintendent Krystal Lomanto indicated that all school districts were working cohesively during this time of COVID 19. She shared that it was a hard decision to stop school attendance through the end of the academic year and implement distance learning.
