Proposed resolution authorizing teleconferencing options for meetings of the Local Agency Formation Commission for the period of October 14, 2021 to November 13, 2021 pursuant to AB 361.

(Agenda Item 4)

REQUEST

It is requested the Commission adopt the proposed Resolution No. 2021-01 authorizing teleconferencing options for meetings of the Local Agency Formation Commission for the period of October 14, 2021 through November 13, 2021, pursuant to AB 361.

DISCUSSION

On June 11, 2021, Governor Newsom issued Executive Order N-08-21, amending his prior Executive Order N-29-20 and waiving certain provisions of the Brown Act relating to teleconferences/remote meetings by local agency legislative bodies. The Executive Order waived, among other things, the provisions of the Brown Act that otherwise required the physical presence of members of local agency legislative bodies or other personnel in a particular location as a condition of participation or as a quorum for a public meeting. These modifications remained in effect through September 30, 2021.

On September 16, 2021, the Governor signed Assembly Bill (AB) 361, a bill that codifies certain teleconference procedures that local agencies have adopted in response to the Governor's Brown Act-related Executive Orders. Specifically, AB 361 allows a local agency to continue to use teleconferencing under the same basic rules as provided in the Executive Orders under certain prescribed circumstances or when certain findings have been made and adopted by the local agency legislative body.

When the state of emergency lasts longer than 30 days, as is the case presently, the legislative body must make findings every 30 days to continue using the bill's exemption to the Brown Act teleconferencing rules. AB 361 mandates that the legislative body must find that there is a continuing need for teleconferencing due to dangers posed by the

ongoing state of emergency. This means that local agencies will have to put an item on the public meeting agenda at least every thirty days to make findings regarding the circumstances of the emergency and to vote to continue relying upon the law's teleconference provisions.

In order to continue to meet under those modified rules after November 13, the Commission will again need to reconsider the circumstances of the state of emergency and again make one of the additional findings required by AB 361.

Reducing the circumstances under which people come into close contact remains a vital component of the County's COVID-19 response strategy. Local agency public meetings are an essential government function and the last 18 months have proven that the hybrid format protects public access while minimizing exposure to COVID-19.

Staff therefore recommends that the Commission adopt findings that conducting inperson meetings at the present time would present an imminent risk to the health and safety of attendees. A resolution to that effect and directing staff to return each 30 days to afford the Commission the opportunity to reconsider such findings, is included herewith. If the Commission adopts the proposed resolution, they may continue to meet under the modified Brown Act teleconference rules of AB 631 through November 13, 2021.

RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSION OF SAN BENITO COUNTY AUTHORIZING CONTINUED REMOTE TELECONFERENCE MEETINGS PURSUANT TO AB 361

WHEREAS, the Local Agency Formation Commission of San Benito County is committed to preserving and nurturing public access and participation in Commission meetings subject to the Ralph M. Brown Act ("Brown Act"); and

WHEREAS, the Brown Act, Government Code section 54953(e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, on March 4, 2020, Governor Newsom issued a Proclamation of State of Emergency in response to the COVID-19 pandemic; and,

WHEREAS, the proclaimed state of emergency remains in effect; and,

WHEREAS, on March 17, 2020, Governor Newsom issued Executive Order N-29-20 that suspended the teleconferencing rules set forth in the California Open Meeting law, Government Code section 54950 et seq. (the "Brown Act"), provided certain requirements were met and followed; and.

WHEREAS, on June 11, 2021, Governor Newsom issued Executive Order N-08-21that clarified the suspension of the teleconferencing rules set forth in the Brown Act, and further provided that those provisions would remain suspended through September 30, 2021; and,

WHEREAS, on September 16, 2021, Governor Newsom signed AB 361 that provides that a legislative body subject to the Brown Act may continue to meet without fully complying with the teleconferencing rules in the Brown Act provided the legislative body determines that meeting in person would present imminent risks to the health or safety of attendees, and further requires that certain findings be made by the legislative body every thirty (30) days; and,

WHEREAS, California Department of Public Health ("CDPH") and the federal Centers for Disease Control and Prevention ("CDC") caution that the Delta variant of COVID-19, currently the dominant strain of COVID-19 in the country, is more transmissible than prior variants of the virus, may cause more severe illness, and that even fully vaccinated individuals can spread the virus to others resulting in rapid and alarming rates of COVID-19 cases and hospitalizations (https://www.cdc.gov/coronavirus/2019-ncov/variants/delta-variant.html); and,

WHEREAS, the Commission has an important governmental interest in protecting the health, safety, and welfare of those who participate in meetings subject to the Brown Act; and,

WHEREAS, in the interest of public health and safety, as affected by the emergency caused by the spread of COVID-19, the Local Agency Formation Commission of San Benito County deems it necessary to find that a requirement to meet in person for meetings of the Commission would present imminent risks to the health or safety of attendees, and thus, intends to invoke the provisions of AB 361 related to teleconferencing; and,

WHEREAS, on September 30, 2021, Dr. Ghilarducci, Interim San Benito County Public Health Officer, issued a recommendation on Social Distancing, attached hereto as Exhibit "A", and incorporated herein by this reference; and,

WHEREAS, the Commission has considered all information related to this matter, as presented at the public meetings of the Commission, including but not limited to the current circumstances related to the state of emergency, which continues to remain in active.

WHEREAS, the Commission further finds that the state of emergency continues to directly impact the ability of the members to meet safely in person.

NOW, THEREFORE, BE IT RESOLVED, by the Local Agency Formation Commission of the County of San Benito as follows:

- 1. The Commission finds that the facts set forth in the recitals to this Resolution are true and correct.
- 2. The above findings and this resolution apply to all meetings of the Local Agency Formation Commission of San Benito County subject to the Brown Act for the period of October 14, 20-21 to November 13, 2021.
- 3. As long as the State Emergency remains in effect or until directed otherwise by the Commission, staff shall present to the Commission at every meeting as necessary, an item to continue the findings required by AB 361.
- 4. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of thirty (30) days from adoption of the Resolution or such time the Commission adopts a subsequent Resolution in accordance with Government Code section 54953(e)(3) to extend the time during which the Commission may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953; and,

5. The Executive Officer and LAFCO Counsel are directed to take such other necessary or appropriate actions to implement the intent and purposes of this resolution.

Re: Recommendation on Social Distancing and Hybrid Meetings

Given the considerable impact on our community from the COVID-19 virus and the Delta variant, I strongly recommend that all legislative bodies, including but not limited to the County, cities, and special districts, local commissions and committees, and subsidiary bodies, continue social distancing measures for public meetings, including offering, at the legislative body's discretion, a remote or hybrid format for public meetings. Social distancing and masking remain crucial strategies in our fight to prevent contagion. Conducting public meetings in a remote or hybrid manner allows for members of the community to participate from the comfort of their homes without having to risk contracting the virus by attending in-person meetings.

These measures serve to help contain the spread of the disease and protect the community. All events public gatherings, including public meetings, create environments where a virus can potentially spread among attendees and participants. However, when combined with social distancing and masking policies, and the continued effort to increase vaccination within San Benito County, a remote or hybrid format for meetings maximizes avenues for public access and input and minimizes the risk of contagion for not only the public, but for agency staff, presenters, and legislative body members as well.

BUSINESS ITEMS – GENERAL BUSINESS, NON-HEARING ITEMS:

6. LAFCO 540 - City of Hollister Out of Agency Service extension to the Sunnyslope Christian Center: To provide a City sewer connection to the Sunnyslope Christian Center for a pending expansion and to replace the existing on-site septic system. The property consists of a 3.75 acre parcel located at 1520 Sunnyslope Road, approximately 500 feet east of Clearview Drive within the Hollister Sphere of Influence. The actions requested are to make an environmental determination regarding the adequacy of the County's Environmental Determination and consider approval of the sewer service extension from the City.

Executive Officer Bill Nicholson gave a brief overview of the out of boundary request for sewer extension from the City of Hollister. This property currently relies on a septic system, and they got an expansion approved by San Benito County because of the size and amount of use but can't expand the septic any further so they need to connect to the City of Hollister sewer. The City of Hollister has agreed and drafted a Resolution and initiated an application to LAFCO. This property is surrounded by the city on three sides. The property owners have agreed that they will not protest annexation in the future in return for getting the sewer service and the property is within the sphere of influence. It makes sense not to require annexation at the moment and then some day in the future it can be annexed. Staff would support this annexation.

Commissioner Velazquez stated they went through this at the city and the applicant was willing to do all the items that were needed. They came to an agreement on this one as it reflects existing conditions of developed property.

Commissioner Bettencourt asked Commissioner Velazquez what Rule 20 was because he wants the public to know what it is. It is an agreement with Santana Ranch to put the power lines underground. One of the things that concerns him is that they would like to annex them into the city, but if they did the county might have an issue with Rule 20.

Commissioner Gonzalez had no comments.

Commissioner Flores had a question on page 3, item 5 of the Environmental Justice. He wanted to know if we are going to be getting rid of their septic system.

Commissioner Velazquez clarified that the applicant would be paying all the cost.

Commissioner Velazquez made a motion to approve Option 1A, seconded by Commissioner Flores.

Commissioner Tiffany explained that a few years ago the meetings were held at 3:00 pm or in the afternoon and to his understanding the time was changed to accommodate the previous chair.

Commissioner Velazquez stated that the time has changed over the years, the thought was that if the meetings were later in the day more people would show up, but that has not been the case and changing it later in the day has also made it difficult for other members and for staff. It seems like an appropriate time would be at 4:00 PM.

Commissioner Tiffany agreed that 4:00 PM would work better for him as well.

Commissioner Bettencourt stated it didn't make a difference for him because he is retired.

Executive Officer Bill Nicholson stated that the earlier the meeting is the better since he lives in Merced, but that he would come at any time.

Commissioner Gonzales stated that if 3:00 PM was an option she would support that due to the increase in the traffic for Mr. Nicholson coming from Merced later on in the day and also for staff and Madame Clerk. She preferred 3:00 PM, but 4:00 PM would be fine.

PROJECT INFORMATION & DETERMINATIONS

1. Land Use, Planning and Zoning - Present and Future:

> The parcel contains one single family home and an outbuilding. The proposed annexation will make community water service available to the property to replace an existing well with water quality and quantity limitations. The County General Plan designates the area as Rural (R), and the zoning has the corresponding designation of Rural (R), which matches the density of development in the vicinity with three to five net acre and larger sized parcels.

> All surrounding land uses are also rural with the Granate Rock Company owning the open space/range land to the east which acts as a buffer to their quarry. The District notes the annexing parcel is within the District's Sphere of Influence and the recently approved Bravo Annexation (LAFCO File No. 532) is located to the southwest of the Martinez parcel. There is an existing District water main in Cole Road which will serve the parcel (as identified in Attachment 1).

2. Topography, Natural Features and Drainage Basins:

> The site and surrounding areas are rolling coastal hills with oak trees. There will be no issues with the installation of a water tie line onto the property.

3. Population:

There is only one home on the annexing parcel, therefore the annexation can be considered "uninhabited" (less than 12 registered voters) under the Government Code definition for LAFCO proceedings. Annexation is not expected to result in construction of any additional homes or in an increase of population. The landonwer has consented in writing to the annexation so there will not be a need for a protest hearing.

4. Governmental Services and Controls - Need, Cost, Adequacy and Availability:

The District's "Plan for Providing Services" is addressed in response to Question 14 on the "Proposal Justification Questionnaire for Annexation" as required by the Government Code attached to this report, and is supplemented with information from the recent Cole Road Annexation (LAFCO File No. 532). The District has 965 current metered water connections although 47 are inactive. The water demand of the one new connection will not impact the District's domestic water supply as the existing three active wells have a design capacity of 2,005 gallons per minute (gpm) and the current capacity use is only 1,500 gpm. The estimated maximum daily demand for one dwellings is only 0.42.

The property at 681 Cole Road, owned by Jose and Lorena Martinez, has had severely diminished water supply as a result of recent drought conditions. Rather than drill a second new well, they are seeking a connection to the Aromas Water District public system which is consistent with recent trends in the Aromas District since even newer private wells are experiencing limited supplies. A connection to this parcel can be installed within 30 days of the annexation. Improvements will consist of a water line and a water meter.

5. Impact on Prime Agricultural Land, Open Space and Agriculture:

The 6.93 acre parcel consists of a rural residential land use which does not produce commercial agricultural crops and does not involve prime agricultural land. The property is not under a Williamson Act contract. Therefore, there will be no impact on agricultural or open space resources from the annexation.

6. Assessed Value, Tax Rates and Indebtedness:

The Tax Rate Area for the parcel identified as APN 011-280-020 is TRA 079-018. The 2020-21 assessed value of the property is \$571,091.

Connection costs and improvements would be paid by the property owner at the time of connection. Ongoing maintenance of facilities is included in the rates charged by the District. The property will not be placed within one of the District's assessment districts.

7. Environmental Impact of the Proposal:

The Aromas Water District, as the "Lead Agency" under CEQA for this project, determined that the annexation qualified for a Categorical Exemption. Sections 15303(d)

and 15319 were referenced in the Notice of Exemption filed by the District with the County Clerk: CEQA Guidelines sections 15303(d) entitled "New Construction or Conversion of Small Structures" including water and other similar utilities, and section 15319 entitled "Annexations of Existing Facilities and Lots for Exempt Facilities." Refer to Attachment 5 for a copy of Resolution No. 2021-07 adopted by the District making the CEQA exemption determination. The Commission can rely on this determination for the annexation in its role as a "Responsible Agency" under CEQA for processing the annexation.

8. Boundaries, Lines of Assessment and Registered Voters:

The boundaries appear to be definite and certain and there do not appear to be conflicts with lines of assessment or ownership. As stated earlier, the parcel is separated from the existing District boundary, with the closest District territory consisting of the recent 18 acre Bravo Annexation located approximately 200 feet to the southwest across Cole Road. The four parcels are contiguous with the current District boundary running along with west side of Cole Road. Staff is still awaiting confirmation from the Contract County Surveyor as to the accuracy of the map and legal description of the annexation territory.

9. Environmental Justice and Affordable Housing

The annexation area is not adjacent to a disadvantaged unincorporated community as the adjacent land located in the County contains large rural residential lots. The annexation of an existing rural residential parcels will not involve any new affordable or market rate housing.

ALTERNATIVES FOR COMMISSION CONSIDERATION

After reviewing this report and any testimony or materials that are presented, the Commission can take one of the following actions:

OPTION 1 – APPROVE the proposal as submitted.






