b) **Unvaccinated Members of the Public:** Masks are required for unvaccinated individuals. 2. Participating by Zoom:

There are three ways to attend Zoom meetings: **over the phone, on a web browser, or through the Zoom App.** Each webinar will have a webinar ID and password, which is a unique number associated with an instant or scheduled meeting (found at the top of this text).

Zoom on Web-browser or Zoom app for Tablet or Smartphone:

Or launch the Zoom app on your Tablet or Smartphone:

1. Select **"JOIN A MEETING"**
2. The participant will be prompted to enter **Webinar ID and Password found above** and name to join the meeting. The meeting agenda can be found at <https://www.cosb.us/>
3. The participant can launch audio through their computer or set it up through the phone.
4. **Public Comment:** Select the **"Participants Tab"** and click **"Raise hand"** icon, and the Zoom facilitator will unmute you when your turn arrives.

1. It will ask you to enter the **Webinar ID, 930 4066 5703**, followed by the **"#" key** (pound key), then enter **Webinar Password, 368103**, which can be found at the top page of the agenda. The meeting agenda can be found at <https://www.cosb.us/>
2. It will then ask for a **Participant ID**, press the **"#" key** (pound key) to continue.
3. Once you enter the Zoom meeting, you will automatically be placed on mute.
4. **Public Comment:** If you are using a phone, please press **"*9"** (star-nine) to raise your hand, and the Zoom facilitator will unmute you when your turn arrives.
